CIVILIAN OF THE MONTH – JUNE 2014 COMMUNICATIONS SUPERVISOR SPERBECK

On Saturday June 7, 2014 at 1329 hours, Communications Supervisor Susie Sperbeck dispatched Surfside Police Officers to 9225 Collins Avenue to a male who had jumped from a 10th floor balcony. Sergeant Patrick McKenna was first to arrive on scene and immediately rendered aid to the victim who had suffered multiple broken bones and was screaming in the pain. Officers Bryant Luke and Antonio Mesa also responded and located the apartment that the male had jumped from. Officers Luke and Mesa cleared the apartment for any other potential victims or subjects that may have been inside and then secured it as a possible crime scene.

Sergeant McKenna secured the scene in the north parking lot where the victim was laying on the ground while waiting for Miami-Dade Fire Rescue to respond. Communications Supervisor Sperbeck played a critical role in making proper notifications and relaying critical facts to the command staff as well as dispatching information to the officers on scene, Miami-Dade Communications, and Miami-Dade Fire Rescue and Air Rescue. During this same time period, Supervisor Sperbeck was dispatching routine calls and answering telephone calls from citizens.

This incident was very critical and a highly stressful event. Exceptional and efficient police work was conducted by all and in particular Communications Supervisor Sperbeck. For her outstanding actions Susie is recognized as the Civilian of the Month for June.

As you are aware the Police Department and the Town experienced recent outages with our phone system carrier where we could not receive incoming calls for a period of time. The backup system we had in place also failed. With the assistance of the Town Attorney's Office and IT Department we have switched over to a new carrier and will have a new backup system in place shortly.

The new laptops will be distributed this month. Lt. Williams will oversee this project.

Lt. Williams, Sgt. Matelis, and Sgt. Torres will be responsible to conduct a mock hurricane exercise and set up the Emergency Operations Center this month.

Surfside, Bal Harbour, Bay Harbor Islands, and Golden Beach Police Departments will implement a new Police Explorer Program this summer. The Explorer Academy will begin on August 2, 2014. Surfside PD will participate in a new north county multi-agency bike patrol deployment program. The Surfside Police Department is offering free residential and commercial security assessments for residents and business owners. Sgt. Matelis is the contact person to schedule the assessment.
