On February 5th, 2016, a witness contacted the Surfside Police Department and reported that he saw a subject enter a Grey Mercedes Benz parked in the 100 block of 95 Street and as the witness approached the subject fled on foot northbound on Collins Avenue. Communications Operator Filiberto immediately issued a detailed description of the subject over Municipal radio. Officers Bobby Gabriel and Joseph Matthews located a subject matching the description of the subject at the 9600 block of Collins Avenue. A Show Up was conducted where the witness positively identified the subject as the individual who entered the parked vehicle. Officer Gabriel and Sergeant Valino interviewed the subject and post Miranda the subject admitted to entering the vehicle. Contact was made with the owner of the vehicle who confirmed his vehicle was entered illegally. Upon further investigation officers found a vehicle registration in a backpack the subject was carrying with an address in Aventura. Officer Matthews contacted the Aventura Police Department and requested they check that address. Aventura PD made contact with the owner of a Silver Mazda SUV who advised they had visited a friend at the Waves Condominium (9455 Collins Avenue) earlier in the evening and had their vehicle burglarized but did not report it. Officer Lovellette responded to Aventura to complete that report. The subject was again interviewed by Officer Lovellette and Sergeant Valino and he also confessed to the second Auto Burglary. It is with great respect and appreciation that I commend the actions, dedication and professionalism of Officer Bobby Gabriel, Officer Joseph Matthews, Officer Craig Lovellette and Communications Operator Filiberto.

POLICE DEPARTMENT RE-ACCREDITATION

The Surfside Police Department is an Accredited Law Enforcement Agency though "The Commission for Florida Law Enforcement Agencies (CFA), Inc." The Surfside Police Department under the leadership of Chief David Allen successfully achieved initial CFA Accreditation in 2009, and Re-Accreditation in 2012. The Surfside Police Department underwent its second Re-Accreditation assessment on January 20th-21st, 2016 that covered the 2012-2015 time frame. The on-site assessment was conducted by three CFA assessors and the Surfside Police Department was successful in the assessment and the CFA Team made a recommendation for Re-Accreditation status. The Re-Accreditation assessment is a rigorous process to ensure that law enforcement agencies are maintaining the highest standards of ethics, professionalism, and are utilizing best practices in conformance with established standards and the law. The recommendation of the CFA Assessment Team was presented to the full commission of the CFA on February 24, 2016 in Saint Augustine, Florida and the full CFA Commission voted unanimously to approve the Re-Accreditation of the Surfside Police Department for another three year period.

The Surfside Police Department is proud to be an accredited law enforcement agency through CFA and demonstrating to the community that the agency is committed to the highest standards of professional law enforcement service.

One of the cameras is plugged into a computer and needs to be charged in that way. The other has a pack to charge the battery in an outlet and is fully charged at this time. They can both be downloaded onto a computer using the cable provided.



PUBLIX SUPERMARKET THEFT ARRESTS

Between October 13, 2015, and January 1, 2016, there were three occasions where wallets had been stolen from the purses of distracted elderly females at the Publix Supermarket located at 9400 Harding Avenue. The subject reportedly struck other Publix Supermarkets in surrounding areas.

On March 3rd, Derrick Hope, 56, was interviewed by Surfside detectives and confessed to committing all three crimes. He was charged with three counts of grand theft and one count of fraudulent use of credit card in connection with three separate crimes.

TOWN OF SURFSIDE LOADING ZONES

In an effort to enhance the flow of vehicular traffic on Harding Avenue and increase the availability of loading zones for businesses, the Town of Surfside has approved the following locations as loading zones between the hours of 6am–10am, Monday through Friday:

- 9500 block of Harding Avenue on the west-side in front of the CVS store (4 parking spaces)
- 9400 block of Harding Avenue on the west-side in front of the Publix Supermarket (4 parking spaces)
- 300 block of 95th Street on the south-side adjacent to the parking lot (3 parking spaces)

These spaces will allow sufficient parking for large trucks that need to unload or load items and place these vehicles outside of the residential areas of Surfside. The new loading zones will be operational beginning Friday 03-05-2016. The aforementioned additional loading zones supplement the existing permanent loading zones that are located in the business district at the following locations:

- 200 block of 95th Street on the south-side (1 parking space)
- 300 block of 95th Street on the south-side (extended area)
- 300 block of 95th Street on the north-side (extended area)

The additional loading zones coupled with the existing loading zones are expected to reduce double parking occurrences on Harding Avenue in the business district and therefore enhance traffic flow and reduce traffic crashes. Surfside Police Officers and Parking Enforcement Officers will monitor these areas for compliance.

BENEFIT FOR THE BUONICONTI FUND

On Saturday, March 5th, the Bal Harbour Shops will be hosting an invitation only benefit for the Buoniconti Fund to Cure Paralysis. Traffic congestion and delays are expected in the area of Collins Avenue and 96 Street as there are over 3 thousand guests expected to attend the event which will include a concert. Police officers will be stationed throughout the area assisting motorists and pedestrians with traffic control. The bulk of traffic is expected from 5:30 p.m. to 6:30 p.m. and at 10:00 p.m. when the event is scheduled to conclude.

LESS-LETHAL SHOTGUNS

The Surfside Police Department has researched the use of less-lethal shotguns, which fire a bean-bag round, and determined that their use is consistent with the department's law enforcement mission. The less lethal shotgun option provides our officers another weapon to distract, disorient, or temporarily incapacitate offenders while keeping officers at a safe distance and allowing for the capture of a suspect without using deadly force. The Surfside Police Department will provide training/qualifications to all sworn officers on the Standard Operating Procedure for the less lethal shotguns and provide hands on training with the weapon during the month of March 2016. The less lethal shotguns will be assigned to all patrol sergeants, and acting patrol sergeants.

SPECIAL INFORMATION/COMMUNITY INITIATIVES/LAW ENFORCEMENT EVENTS

The Police Department received a DAVID Audit Site inspection from the Florida Highway Safety and Motor Vehicles on March 1st at 11:30 a.m. The audit ensured all that Surfside Police Department is in compliance with all regulations and practices of the Department of Florida Highway Safety and Motor Vehicles.
