# HURRICANE IRMA

# **OFFICER OF THE MONTH - AUGUST 2017 – OFFICER LESMES RUIZ**

On August 8, 2017 at 0212 hours officers received a call from the complainant neighbor who advised of a group of juveniles possibly attempting to burglarize a home in the 8900 block of Carlyle Ave. As Officer Ruiz responded to the location he observed a group of three juveniles riding bicycles southbound in the 8800 block of Emerson Ave and promptly separated and detained them as other officers arrived at the incident location. Officers made contact with the homeowner and were able to obtain information that there were two bicycles taken from the front of the home in the driveway area. Officer Ruiz and back up officers individually questioned the three subjects and were able to obtain information from the juvenile subject that they arrived on foot at the location and took two bicycles from a residence in the 8900 block of Carlyle Ave and then took a third bicycle from a separate location. The officers drove the juvenile subject to the area and he was able to point out the home in the 8800 block of Emerson Avenue where the third bicycle was taken. Contact was made with the homeowner who responded to the scene and positively identified one of the bicycles as his. The officer who was at the incident location of 8900 block of Carlyle Ave drove the victim to the location where the juveniles were and he positively identified the other two bicycles as his. All three subjects were arrested and charged with Grand Theft and Petit Theft of the bicycles. Officer Ruiz is to be commended for his alertness and guick thinking in detaining these subjects as he responded to the call. The detaining of the subjects and the investigations at the separate locations ultimately led to the arrests of these subjects and the properties being returned to their rightful owners without any further crimes occurring. # AUGUST SIGNIFICANT INVESTIGATIONS/INCIDENTS

Grand Theft Arrest

08/08/2017 at 0200 Hours: 8900 block of Carlyle Avenue

Officers were dispatched to a possible theft in progress involving three subjects. Upon arrival, three subjects matching the description were observed riding bicycles. Officers stopped the subjects and discovered that they had just stolen two of the bicycles from the front driveway of the residence. The third bicycle was taken from the front porch of a residence in the 8800 block of Emerson Avenue. All bicycles had been left unlocked by the victims. Two subjects were arrested and one was issued a juvenile civil citation.

# Attempted Occupied Burglary/Resisting with Violence/Simple Battery Arrest

08/18/2017 at 1543 Hours: 9000 block of Collins Avenue

Officers were dispatched to a disturbance. Upon arrival, they made contact with two victims and a subject. All persons involved were hanging out until the subject accused one of the victims of owing him money, at which time the subject became violent by pushing and attempting to punch one of the victims. The subject was then pushed out of the apartment by the second victim, who he also pushed and grabbed by the throat. The subject attempted to regain entry to the apartment by kicking the front door and breaking the glass. The subject failed to comply with officers' commands and physically resisted arrest.



# Auto Theft Arrest

08/23/2017 from 0534 hours to 0539 hours: 9400 block of Collins Avenue The victim reported that he valeted his vehicle at the hotel. When the victim returned to retrieve his vehicle from valet, it was discovered that the vehicle and keys were missing. Detectives retrieved surveillance footage of the area and identified that a past hotel employee was in the garage area at the same time the vehicle was stolen. Detectives located the subject and was arrested.

# HIGH HOLIDAY DETAIL

The High Holiday services begin on Wednesday evening, September 20, 2017 and end Saturday, October 14, 2017.

The Surfside Police Department has increased police presence with assigned details for high visibility during the High Holidays in the areas of The Shul 9540 Collins Avenue, Young Israel 9592 Harding Avenue, Hechal Shalom Sephardic Congregation 310 95th Street and Magen David Sephardic Congregation 9348 Harding Avenue. The enhanced patrols will be concentrated before and after services when congregants from the surrounding area and neighboring communities are walking to and from these locations. In addition, Bal Harbour and Bay Harbor Islands Police Departments will assign officers to further augment patrols in the area.

The following actions in accordance with the below schedule have been instituted:

- Assign specific officers to directed patrols with the overhead riding lights on in the residential and high pedestrian areas, focusing on congregants walking to and from local synagogues.
- Assign specific officers to bicycle & Segway patrols in and around the Business District, Collins Avenue and the 96 Street corridor where there is heavy pedestrian travel (rotate as necessary).
- As the shift supervisor, <u>you</u> visit the high risk locations (The Shul, Young Israel), check on their status and make them aware that we are proactively patrolling the areas.
- Have all available units maintain high visibility throughout their shifts, use riding lights in the residential areas for enhanced visibility.

Document all assignments and actions on the End of Shift Report.
