Chapter 106 Florida Statutes, regulating campaign financing in state and local elections, requires periodic reports of all campaign financial activities. All candidates are strongly urged to be thoroughly familiarized with Chapter 106, Florida Statutes.

The Town Clerk will review reports for timeliness of filing. It is the Candidate's responsibility to ensure that the information contained in the report is true, correct, and in accordance with the laws of the State of Florida.

Online submissions must be received no later than midnight of the day designated, per F.S. 106.0705(3). Reports not filed by midnight of the day designated are late and are subject to a fine in accordance with F.S. 106.07(8) (b). All fines must be paid from the candidate's personal funds – NOT campaign funds.

If a candidate announces prior to the qualifying dates, reports should be done on the 10th day following the end of each month from the time the campaign treasurer's is appointed, except that, if the 10th day occurs on a Saturday, Sunday, or legal holiday. FS. 106.07(1).

The deadline for withdrawal for candidates is by end of qualifying, February 2, 2026.

Withdrawal must be done in writing and filed with the Town Clerk by 12:00 p.m. on February 2, 2026.
