#### NEW LAWS

Chapter 2013-58:

New section 316.305 prohibits **texting**, emailing and instant messaging while operating a motor vehicle. Motor vehicles which are stationary are not included. There are also several exceptions to the applicability of the law. It is a non-criminal infraction, but citations can only be issued when an operator of a motor vehicle has been detained for a suspected violation of *another* provision of Chapters 316, 320 or 322.

Chapter 2013-117:

New subsection 837.05(1) (b) makes it a third degree felony for a person to knowingly give **false information to a law enforcement officer about the commission of a crime**, if the person has previously been convicted of the offense **and** either:

1. The information was communicated orally and the officer's account of that information is corroborated by an audio recording, a video recording with audio, a written or recorded statement, or another person was present and heard the false information being given to the officer, or

2. The information was communicated in writing.

## JUVENILE REPORTS

Please ensure that your report is complete and includes the most serious charge. This charge is what determines the offender type. For youths who are detained and then released with no charges after an investigation, should be listed with the charge they were originally detained under. Youths held secure once you have decided to not charge would be a violation and should be entered on the Juvenile Log as such.

Status offenders, youths charged with behaviors that are not illegal for an adult, cannot be held secure for any length of time beyond the fingerprinting and taking photographs. You cannot hold them secure while you are awaiting their parent/guardian to pick them up or during the investigation.

What is secure? Under the JJDP Act, secure is defined as the restriction of movement or the potential restriction of movement through mechanical or constructural means. So placing a youth within an interview room that has the potential to be secured (locked) would be considered secure. Holding a youth who is handcuffed to a stationary object is considered secure. A youth who is handcuffed to himself and held in a report writing room in considered non-secure.
