#### Code Violations

Civil violation notice sometimes referred as citation may be issued by any police officer or code enforcement officer of the town who has probable cause to believe that a person has committed an act in violation of the town of Surfside code of ordinances:

Sec. 10-28 Leash Law - \$50.00

Sec. 10-32 Fecal Disposal - \$100.00

Sec. 10-33 Dog on Beach - \$100.00

- White Violator's copy
  - Yellow Officer's copy
- Manila File copy (forward all hard copies to my attention)

# Move-Over Guide – Sgt. Richard Williams

Due to statutory changes made during the 2009 Regular Legislative Session, the National Safety Commission has updated the Move-Over Guide to reflect current information provided to traffic violators to assist them in disposing of traffic citations. Effective October 1, 2009, legislation was enacted that requires mandatory completion of a Basic Driver Improvement (BDI) course for violators of the following statutes:

1) Running a Stop Sign (Florida State Statute 316.123 (2) (a)

2) Running a Red Light (Florida State Statute 316.075 (1) (c) 1

3) Passing a Stopped School Bus (Florida State Statute 316.172(1) (a) or 316.172(1) (b)

4) Racing on Highway Florida State Statute 316.191(2) (a)

5) Reckless Driving Florida State Statute 316.192(1) (a)

The benefits of using the guide include:

1) public education of the "Move-Over" law;

2) provides detailed information on the manner in which violators can dispose of traffic citations;

3) notifies those violators of the five specific violations that require mandatory completion of an approved Basic Driver Improvement (BDI) course;

4) and most importantly, reduction in the amount of time required to converse with violators on the side of the road regarding the violators' options to appropriately resolve the citation, thus reducing exposure to danger from passing vehicles.

Please hand out the Move-Over Guide subsequent to issuing traffic citations to violators.
