### HOLDING FACILITY/ OFFICER SAFETY

Officers are reminded to transport violent prisoners directly to Dade County Jail. **Violent prisoners are not to be transported to the holding facility.** Unless a prisoner is to be interviewed by CIU or there is another exception, all prisoners should always be transported directly to DCJ. Supervisors will be held responsible.

## JUVENILE PROCEDURES - Sqt. Richard Williams

Requirements of the Federal Juvenile Justice and Delinquency Prevention Act.

Status offenders (juveniles detained for things that adults are not – such as truants, curfew violations, minor in possession of tobacco or alcohol, and runaways) **should never** be held behind doors that contain a lockable device (such as cells, lockable interview rooms) or handcuffed to a stationary object. Status offenders are best held in a non-secure area such as an unlockable interview/ interrogation room, report writing room, or office while awaiting transport to a more appropriate facility or awaiting the parent/guardian to come and get them.

<u>Co-defendants</u> - when they are an adult and a juvenile: While Florida state statute allows for transportation together, once they arrive at our station, they must be sight and sound separated. They cannot be placed within the same room or area where there is any form of contact.

And don't forget that any youth detained for delinquent behavior cannot be held longer than six (6) hours within a secure area of our facility. This core requirement of the Federal Act is mirrored in Florida State Statute 985.115(3).
