OCTOBER SIGNIFICANT INVESTIGATIONS/INCIDENTS

Loitering and Prowling / Resisting Officer without Violence Arrest

10/10/2017 at 1000 hours: 9400 Harding Avenue

Publix management reported a shoplifter had just walked out of their store with unknown items. An officer called over the subject, but the subject only continued walking faster away. A B.O.L.O. was issued on the radio and officers quickly located the subject nearby. Publix refused to prosecute for the shoplifting. However, he was arrested for resisting officers without violence and loitering & prowling in the area.

Failure to Obey Police Officer / Disorderly Conduct Arrest

10/10/2017 at 1100 hours

90th Street and Collins Avenue

Subject was illegally blocking the east lane of Collins Avenue and refused to move after being asked by an officer to do so. Officer then approached the subject to deliver him a citation at which point the subject began yelling, cursing, and pointing his finger at the officer's faces. The subject made a scene in the middle of the roadway. The subject was arrested.

Auto Burglary: 173314

10/15/2017 between 1200 – 0200 hours

8900 block of Carlyle Avenue

An unlocked vehicle parked in his driveway of a residence was entered by an unknown subject(s). A Dewalt hammer drill valued at \$300.00 dollars was taken from the vehicle. No one witnessed the incident and there are no cameras in the area.

Armed Robbery/ Kidnapping

10/19/2017 between 1715 hours and 1834 hours: 94th Street and Harding Avenue

The victim placed an ad on the Offer Up website to sell his iPhone 6 and was contacted by a buyer who expressed interest in purchasing the cellular telephone. They arranged to meet at 94th Street and Harding Avenue. Upon meeting with the buyer, the victim entered his vehicle which was occupied by a female driver and a male passenger. After the male inspected the victims' phone he produced a black pistol, pointed it at the victims head and went through the victim's pockets taking his personal cellular telephone. The male held down the victim's arm and told him several times to lay down on the seat. The female then drove south bound on Harding Avenue from 94th Street to 73rd Street, at which point they stopped. The victim was ordered to exit the vehicle and told to walk in the opposite direction. Both subjects were positively identified by detectives and on 10/25/2017, the female subject was located and arrested. The male subject remains at large, however detectives are obtaining a warrant for his arrest.

Auto Burglary

10/18/2017 between 1915 hours and 2030 hours: 9500 block of Collins Avenue (Post Office Parking Lot)

An unknown subject(s) entered a vehicle and stole a Silver Cannon camera, along with several books (total value \$3,180.00 dollars. There were no signs of forced entry on the vehicle. There are no witnesses to this incident, nor are there any surveillance cameras that cover the area.

An unknown person(s) shattered the passenger side window of a vehicle which was parked on the street in front of a residence. The only item taken from the vehicle was a cellular telephone charger. This case is currently under investigation.

A vehicle parked in the rear parking lot of Flanigan's was stolen, the key was left inside. On 10/28/2017, the vehicle was recovered by Lauderhill Police Department in good condition. Crime scene processed the vehicle and were able to lift fingerprints. This case is currently under investigation.
