MAY SIGNIFICANT INVESTIGATIONS/INCIDENTS

Burglary Arrest

05/09/2018 at 0800 hours

9500 block of Collins Avenue

Officers responded to a call of a suspicious male who was captured on surveillance video entering multiple apartments in the building. The male was also observed taking a beach chair from a balcony. The male was located by officers near the bushes on the east side of the building. He was interviewed by officers and confessed to entering units and taking the chair. The male was arrested and charged with unoccupied burglary to a dwelling.

Hit & Run Arrest

05/09/2018 at 1605 hours

89th Street and Harding Avenue

Officers responded to a call of a Hit and Run. The victim had a visible hand injury that was bleeding heavily. The victim gave a description of the subject and the vehicle to officers. The subject's vehicle was located minutes later parked in the driveway of a residence in the residential neighborhood. The subject made an apparent attempt to remove any evidence from his vehicle which was freshly wet with the lawn hose still in the driveway next to the vehicle. However, there were still drops of what appeared to be fresh blood on the hood of the vehicle which was later collected by Miami Beach Crime Scene. When confronted by officers, the subject stated that his vehicle only "touched" the victim. The victim identified the subject as the male who struck him with his vehicle and fled the scene. The male was arrested and charged with one count of leaving the scene of a crash with injuries.

Stolen Vehicle Recovery

05/15/2018 at 0753 hours

600 block of 91st Street

Officers responded to a call of an unoccupied suspicious vehicle left running at the above location. A record check of the vehicle revealed it was reported stolen to the City of Miami Police Department. The City of Miami Police Department was notified of the recovery and the vehicle was towed to Beach Towing.

Stolen Vehicle 05/18/2018 at 0940 hours

200 block of 88th Street

The victim parked his vehicle in the 200 block of 88th Street at approximately 0005 hours and discovered that it was stolen when he returned at approximately 0940 hours. There are no witnesses to this incident and no CCTV that cover the area where the vehicle was parked. This case is currently under investigation.



Residential (Distraction) Burglary 05/27/2018 between 1600 hours and 1620 hours 1300 block of Biscava Drive

A young white male, who looked to be in his teens knocked on her door of a residence and asked the homeowner if she remembered him. He told her he used to be her nextdoor neighbor and asked for her husband by name referring to him as uncle. The victim believed that she recognized the subject as a previous neighbor of hers and asked him to come in. The victim offered the subject mangos from her tree to take to his mother. The subject told her that he had a plastic bag inside of his vehicle and that he would be right back. The victim gave the subject mangos and the subject left a short time later. That evening the victim went upstairs to her bedroom and noticed her closet was ransacked and her vanity drawers were pried open. Approximately \$30,000.00 dollars' worth of jewelry and \$650.00 dollars in U.S. currency was stolen. Miami Beach Crime Scene responded and processed the area, obtaining one latent finger print. This case is currently under investigation.

Animal Cruelty

250 95th Street – Post Office parking lot

A new born puppy was found in a garbage bag in the dumpster. Two other puppies were found in the bag but were deceased. There are no witnesses to this incident and no CCTV that cover the area. The complainant volunteered to care for the puppy after attempts were made to contact Miami Dade Animal Services and the Humane Society. This case is currently under investigation.
