OFFICER OF THE MONTH – APRIL 2018 - OFFICER JOHN GENTILE

On the night of Wednesday, April 11th, 2018 at approximately 2100hrs, a Bay Harbor Islands Police officer advised the Surfside Police Department that upon responding to a barking dog call he observed a dog in distress swimming along the seawall in the area of the 9400/9500 Block of Bay Drive. Officer John Gentile arrived in the area moments later. Officer Gentile observed the dog swimming southbound in the waterway behind the 9300 Block of Bay Drive. The dog was struggling and unable to exit the water onto land. Officer Gentile entered other back yards and also saw the dog, however were not able to grab him as the docks were too high above the water. Officers lost visual of the dog as he kept swimming and Officer Gentile requested the assistance of the Indian Creek Police Marine Unit. Officer Gentile then moved further south in the 9300 Block of Bay Drive and entered a backyard where he discovered a plastic floating dock. Officer Gentile saw the dog swimming toward him, jumped down on the floating dock and was able to grab the dog by a harness and pull him out of the water. The dog, Max, had a tag with a Surfside address. Officer Gentile responded to the address and returned the dog to the owner who was unaware of the incident and was very appreciative that Officer Gentile's selfless actions saved his dog's life. Officer Gentile's quick actions, determination and lack of concern for his own safety resulted in locating and saving the dog's life. APRIL SIGNIFICANT INVESTIGATIONS/INCIDENTS

Occupied Residential Burglary 04/06/2018 between 1730 - 1900 hours 9400 block of Carlyle Avenue

An unknown male subject entered a residence, while the elderly female home owner was inside. She observed the subject who she could only describe as a black male, walk through the home and exit via the front door. During this same time, the elderly male home owner was in the front yard watering the plants and had the front door unlocked and slightly ajar. Two Rolex watches, two gold necklaces, and a wallet containing miscellaneous credit cards were taken along with approximately \$700.00 dollars in U.S. currency. Their adult son, who loves with them, received a notification from his bank alerting him to a possible fraudulent transaction at Target. A need to identify flyer was distributed to neighboring police departments, a Community Awareness Flyer was disseminated and a media interview was conducted on the incident. This case is currently under investigation.

Leaving Scene of Crash involving Injury and DWLS w/knowledge Arrest

04/11/2018 at 1400 hours

94th Street and Collins Avenue

Officers responded to a call of a Hit and Run with injuries where a bicyclist was hit by a vehicle. The victim was found lying on the side walk with scratches and abrasions and his bicycle was 50 feet away from him. Multiple witnesses observed a vehicle veer to the side of the road and strike the victim, who was riding his bicycle on the sidewalk. A B.O.L.O. was issued and momentarily a Bal Harbour officer advised he was behind the vehicle. The driver refused to pull over and after stopping ignored officers' commands. The subject was apprehended after being tased. An open container of alcohol, a large amount of marijuana, prescription medication, and a large quantity of cash were discovered inside the subject's vehicle. A records check revealed the subject had a suspended driver's license. The subject was arrested and charged with one count of leaving the scene of a crash involving injury and one count of driving while license suspended with knowledge by SPD and charged with several felonies by Bal Harbour Police Department.

Special Incident

04/11/2018 at 2108 hours

9300 - 9400 block of Bay Drive - Waterway

Officers were dispatched to a call of a dog in distress in the intercoastal water, along the seawall. Officers arrived, located the dog, and were able to jump down onto a plastic floating dock to pull the dog out of the water and onto dry land saving the dog's life. An officer located the owner of the dog and safely returned the dog back to its owner.



Suspicious Incident 04/13/2018 at 1050 hours 9000 block of Collins Avenue

A female employee of the hotel stated that on 03/28/2018 at approximately 0000 hours, while sitting at the bus stop waiting for the bus she was approached by a male. The male engaged her in conversation, asking several personal questions. The male then grabbed the female by the arm and told her "You're going to the beach with me", to which the female replied "no". The male made the statement several more times while holding onto her right arm. The bus arrived and the female was able to board the bus and leave the area with no further incident. On 04/12/2018, during a separate incident the same male was trespassed from hotel. On 04/13/2018, the employee reported her incident to the hotel security director after seeing the male at the hotel the previous day because she was afraid. A Suspicious Incident flyer was generated and distributed to surrounding jurisdictions.

Grand Theft

04/16/2018 at 1215 hours

9400 block of Harding Avenue

Unknown subject(s) stole a purse from a stool near the rear entrance of a store. The purse contained the victim's wedding rings, a wallet with multiple credit cards, the victim's passport, social security card, and a pair of sunglasses. A total value of \$16,000.00 dollars. A short time after the theft, two male subjects were captured by CCTV attempting to use the victim's credit cards at the Walmart in Hallandale and at the Target and Best Buy in Aventura. A Need to Identify flyer was distributed to neighboring police departments, a Community Awareness Flyer was disseminated and a media interview was conducted on the incident. This case is currently under investigation.

He then checked his trunk and also noticed that more items were missing. The victim returned to Surfside to report the incident and informed the officer that he was not sure whether or not he left his vehicle locked or unlocked. A total value of \$335.00 dollars. This incident is currently under investigation.

NATIONAL POLICE APPRECIATION MONTH

May is the month where the Nation celebrates Memorial Day and National Police Appreciation Month.

In 1962, President John F. Kennedy signed a proclamation which designated May 15th as Peace Officers Memorial Day and the week in which that date falls as Police Week. Currently, tens of thousands of law enforcement officers from around the world converge on Washington, DC to participate in a number of planned events which honor those that have paid the ultimate sacrifice. The Memorial Service began in 1982 as a gathering in Senate Park of approximately 120 survivors and supporters of law enforcement. Decades later, the event, more commonly known as National Police Week, has grown to a series of events which attracts thousands of survivors and law enforcement officers to our Nation's Capital each year.

Locally there are several events to honor the men and women of law enforcement.

The Law Enforcement Officers Memorial was established in 1980 to honor fallen officers from every police department and law enforcement agency within Miami- Dade County. In 2001, four black granite walls were erected; etched with the names of the gallant men and women who died serving the citizens of their community.

The Eternal Blue Line Flag will be flown over Surfside Town Hall in the honor of the fallen officers for the month of May.
