SIGNIFICANT INVESTIGATIONS/INCIDENTS

Auto Theft/Leaving Scene of Accident/DWLS Arrest 11/03/2019 at 0100 hours 900 block of 88th Street

Officers responded to a call of a hit and run. Officers discovered three vehicles involved. Prior to the officers arriving, the subject fled his vehicle on foot but was quickly followed by a witness and brought back to the scene. The investigation determined the subject crashed into a parked vehicle on Biscaya Drive, then made a U-turn and traveled a short distance and crashed into another parked vehicle on 88th Street, at a high rate of speed. All three vehicles involved had extensive damage. A records check revealed that the subject was driving a stolen vehicle reported by Miami Beach. The male subject was arrested.

Update: Battery by Strangulation Domestic Violence Arrest

11/25/2019 at 1210 hours 9293 Harding Avenue

On 11/24/2019, officers responded to a battery in progress between a boyfriend and girlfriend. The victim stated that the male/boyfriend had choked her and threatened to kill her with a firearm. The victim was observed to have abrasions to her neck and chin area. Officers made contact with the male and discovered that he had a semi-automatic 45 ACP pistol concealed on his person. Consent was given by the male to search his vehicle and a semi-automatic AR-15 rifle was found in the truck of the car. The subject was arrested. The weapons were impounded into the Property and Evidence Unit. On 11/25/2019, an additional charge for battery by strangulation was added. The additional charge was regarding a previous similar incident involving the same victim which occurred on 04/26/2019.

Grand Theft Auto Arrest 11/25/2019 at 2010 hours 8900 block of Dickens Avenue

During a traffic stop, a records check of the vehicle revealed it had been stolen on 11/21/2019, from Hollywood, FL. The driver stated that she recently purchased the vehicle. However, the victim reported that after he received a \$200.00 dollar deposit from the driver, the driver never returned to satisfy the remaining debt of \$4,700.00 dollars. The driver was arrested.
