## OFFICER OF THE MONTH - JUNE 2019 - DETECTIVE DIANA DULANEY

On Sunday, June 16th, 2019, an unlocked bicycle was stolen valued at \$1,000.00 dollars from the rear entrance of CVS Pharmacy. Detective Diana Dulaney began investigating the theft by reviewing nearby surveillance video footage and was able to locate the subject riding away on the victim's bicycle. She created a flyer with an image of the subject and distributed it to surrounding police agencies. Detective Dulaney followed-up on a Field Interview Report written the day prior to the theft by Officer Matthews. The appearance of the male interviewed was very similar to the appearance of the subject captured on video taking the bicycle. Detective Dulaney researched the male's previous arrests and discovered that he had been arrested in Surfside on April 10th, 2019, for petit theft. Detective Dulaney contacted Officer Hernandez who previously arrested the subject and positively identified the subject off of the flyer as being the same subject she had arrested. After identifying the subject, Detective Dulaney had probable cause for his arrest and began the search for the subject, who was believed to be homeless. On Tuesday, June 25th, 2019, Detective Dulaney and Detective Gambirazio placed him in custody and transported him to the Surfside Police Department.

Due to the abundance of recent bicycle thefts, Detective Dulaney interviewed the subject in hopes of solving other bicycle theft cases. During the interview, the subject confessed to taking the victim's bicycle and further admitted to taking other bicycles. However, he could not provide exact locations or descriptions of the other bicycles. The subject was arrested and charged with one count of grand theft. Detective Dulaney is commended for her tireless tenacity in arresting this subject and overall conducting a very thorough investigation. Congratulations to Detective Diana Dulaney as the recipient of Officer of the Month...well deserved!

#### SIGNIFICANT INVESTIGATIONS/INCIDENTS

Lewd and Lascivious Exposure 06/21/2019 at 0800 hours 9500 block of the Beach Area

A white male, 35-45 years of age, wearing only an olive-green towel approached the victims, at the above listed location and began masturbating. The male was last seen southbound on the beach. The victims fled the area on foot to Starbucks and the Police were called. The area was canvassed on foot, Polaris, and police vehicles, with negative results. A BOLO was issued on Miami-Dade County Municipal frequency and Miami Beach Police Department was contacted. Surrounding agencies also assisted in the search. A detailed area canvas was conducted and all of the condominiums and hotels located on Collins Avenue were checked, for camera footage, which yielded negative results.

Update: Bicycle Theft Arrest

9578 Harding Avenue – CVS Pharmacy

On 06/16/2019, an unlocked bicycle valued at \$1,000.00-dollars was stolen from the rear entrance of CVS Pharmacy. The CCTV footage was reviewed and a male subject was observed riding southbound on the bicycle. During the investigation, it was discovered the subject in the CCTV footage resembled a subject who had been stopped by a Surfside officer on June 15, 2019. A flyer was created and disseminated to the surrounding police agencies. The subject was identified through an arrest in Surfside on April 10, 2019 and probable cause was established. On 06/25/2019, while following-up on leads, detectives located and apprehended the subject in Aventura, FL. The subject was interviewed and gave detectives a full confession. He was arrested and charged with one count of grand theft.
