SIGNIFICANT INVESTIGATIONS/INCIDENTS

Residential Burglary 04/30/2019 at 2100 hours - 05/01/2019 at 0730 hours 8800 block of Carlyle Avenue Unknown subject(s) entered an unlocked backyard shed and stole a bicycle. The bicycle was valued at \$1,700.00 dollars.

Residential Burglary 03/29/2019 at 1428 hours - 05/02/2019 at 1800 hours 9200 block of Byron Avenue Officers responded to a call of an open back door. Upon their arrival, the house was searched, but no subjects were located. The neighbor, who cares for the homeowner's house advised that the house is a vacation home and the homeowner lives in Canada. The house was ransacked, but nothing of value was taken.

Recovered Stolen Vehicle

05/05/2019 at 0240 hours

200 block of 91st Street

Officers responded to a call of three suspicious males loitering in the parking garage. Upon arrival, the males were no longer on scene. The residential area was saturated with officers searching for the subjects, but they were not located. Officers located a vehicle abandoned by the subjects, which they quickly discovered was reported stolen on 04/06/2019, from the City of Pembroke Pines. The vehicle was towed and Pembroke Pines Police Department was notified.



Assist Other Agency 05/11/2019 at 0315 hours 9000 block of Harding Avenue

Surfside officers received a B.O.L.O. over the municipal radio for a vehicle that was involved in a homicide in Miami Beach. A short time later, Miami Beach Police officers pursued the vehicle through the Town of Surfside into the Village of Bal Harbour. The vehicle made a U-turn and headed south on Harding Avenue, back through Surfside. Officers pursuing the vehicle lost sight of it in the area of 93rd Street and Harding Avenue. Two Miami Beach Police Department units were involved in a crash during that pursuit in the 9100 block of Harding Avenue. It was later discovered that additional vehicles were involved in the shooting. A second B.O.L.O. was issued for a black Chrysler 300 which was subsequently located in the 200 block of 93rd Street with one occupant. That person was detained for questioning by MBPD.

Auto Burglaries Arrest

05/17/2019 between 0135- 0335 hours

8800 block of Collins Avenue

A surveillance video camera captured an unknown subject exit a dark vehicle with no visible tag and enter the parking garage, within the same timeframe as the burglaries occurred. Two unlocked parked vehicles were burglarized and construction tools, a pair of sunglasses, and an iPhone charger were taken. A law enforcement BOLO flyer and a Surfside Community Flyer were distributed. On 05/22/2019, Surfside detectives, through investigative leads, interviewed a male subject who they believed was involved in this incident. The male gave a full confession and admitted to burglarizing both vehicles. The male was charged with burglary to an unoccupied conveyance for each incident.

Auto Burglaries Arrest

Between 05/16/2019 1200 - 05/17/2019 1800 hours

9100 block of Dickens Avenue

Unknown subject(s) entered two unlocked vehicles parked in the driveway of a residence. Subject(s) took a purse, a pair of shoes, and clothing. On 05/28/2019, Surfside detectives interviewed a juvenile male who they believed was involved in this incident. The juvenile male gave a full confession, admitting to burglarizing a total of three vehicles including the vehicles from the incident on 05/17/2019 in the 8800 block of Collins Avenue. The juvenile male was charged with burglary to an unoccupied conveyance.

Auto Burglaries

05/18/2019 between 0012 - 0330 hours

9100 and 9000 blocks of Froude Avenue

A victim witnessed a male subject inside his vehicle with a flashlight, then fleeing into a gray Dodge Charger or Challenger which was being driven by another male subject. Upon officers arrival in the area, the subjects and vehicle were gone. Two unlocked vehicles were burglarized and sunglasses and a gift card were taken. An area canvass revealed a few surveillance cameras which depicted an unknown vehicle casing the area, but no subjects were captured.



Loitering and Prowling / Carrying Concealed Weapon Arrest 05/18/2019 at 0830 hours 9400 block of Bay Drive

While on routine patrol in the residential area, an officer observed a suspicious male walking. The officer became increasingly suspicious once the male noticed the officer and began to change directions and reached down towards his waistband. The subject had a noticeable bulge in his waistband. The officer stopped the male and discovered an 18-inch machete concealed in his waistband. The male had no reason for being in the residential area and could not dispel the officer's alarm for the safety of persons and property in the community. The machete was impounded and the male was arrested.

Unknown subject(s) stole approximately \$3,000.00 dollars' worth of clothing from the trunk of a vehicle parked in the driveway of a residence. There was no sign of forced entry and the victim insists the doors were locked and the trunk was secured by him prior to going inside for the evening.
