SIGNIFICANT INVESTIGATIONS/INCIDENTS

Auto Theft and Loitering or Prowling Arrest 10/30/2019 at 0930 hours 9100 block of Carlyle Avenue

Officers responded to a call of a suspicious vehicle. Upon making contact with the driver of the vehicle, a records check revealed the vehicle was reported stolen out of the City of Miami. The driver was detained and interviewed by patrol. The driver gave conflicting stories and failed to dispel the officer's alarm. The driver stated the car belonged to his girlfriend and he had permission to drive it. The owner of the car was contacted and stated the driver did not have permission to drive her car and she is not his girlfriend. The owner stated that the driver took her car without permission and the driver was arrested.

Auto Theft/Leaving Scene of Accident/DWLS Arrest 11/03/2019 at 0100 hours 900 block of 88th Street

Officers responded to a call of a hit and run and discovered three vehicles were involved in the accident. Prior to the officers arriving, the subject fled his vehicle but was quickly followed by a witness and brought back to the scene. The investigation determined the subject crashed into a parked vehicle on Biscaya Drive, then made a Uturn and traveled a short distance and crashed into another parked vehicle on 88th Street, at a high rate of speed. All three vehicles involved had extensive damage. A records check revealed that the subject was driving a stolen vehicle reported by Miami Beach and the male subject was arrested.
