OFFICER OF THE MONTH - SEPTEMBER 2019 - OFFICER EDWARD CARRASQUILLO

On September 26, 2019, at approximately 11:30 a.m., Officer Carrasquillo observed two juveniles acting suspiciously in the residential neighborhood. Officer Carrasquillo followed them for several minutes. Their direction of travel changed several times in an attempt to elude him. The juveniles were riding on one bike together and appeared to be casing the area. Officer Carrasquillo stopped the two and post Miranda per card, the juveniles admitted to being suspended from school. They said they were in the area to go to the beach however they were wearing hoodies, jeans and sneakers. The juveniles did not know anyone in the area. They had a backpack in their possession which contained burglary tools. The juveniles failed to dispel Officer Carrasquillo's concerns for the safety of the community. Both subjects were arrested for Loitering and Prowling. Officer Carrasquillo's alertness and keen observation skills led to the arrest of two juveniles that were out of school with no explanation for their actions. Officer Carrasquillo is commended for his professionalism and commitment to protect and serve the Town of Surfside. Auto Burglary

Unknown subject(s) burglarized a company vehicle parked at a residence. The victim was unsure if he left it unlocked, however no pry marks were seen. The subject(s) stole several construction tools totaling \$2,400.00 dollars from the vehicle. No surveillance cameras or witnesses were located.

Unknown subject(s) stole a moped parked in a parking space in the gated parking garage of his building. The garage is gated and locked, however can be opened without a fob from the inside. An area canvass revealed no surveillance cameras or witnesses. The stolen moped was entered into the national database as stolen. On 09/08/2019, the moped was located and recovered by FHP, who found it abandoned in Key West, FL. The owner was notified.

Auto Burglary

9100 block of Carlyle Avenue

Unknown subject(s) burglarized a vehicle parked in the driveway of a residence. A nearby surveillance camera captured the incident and the subjects entering the victim's vehicle. Two subjects, unknown race or sex, were captured on surveillance walking along Carlyle Avenue on Friday, September 6th, 2019, at approximately 0400 hours. One subject, walked up to the victim's vehicle and entered through the passenger side door. The second subject walked up and opened the driver's side door. Both subjects were captured walking away southbound on Carlyle Avenue.

Auto Burglary

Unknown subject(s) burglarized a vehicle parked in the driveway of a residence. Approximately \$5.00 dollars in coins, a \$20.00-dollar bill, and an identification card were taken from the vehicle. There were no signs of forced entry to the vehicle. There were no witnesses or CCTV footage of this incident.



Threats to Kill Arrest 09/14/2019 at 1220 hours 9401 Harding Avenue – Wells Fargo Bank

Officers were dispatched to a threat involving a firearm. Upon arrival, bank personnel advised the subject made several phone calls to the bank, in an attempt to speak to the bank manager over an earlier parking dispute. The subject was connected with the manager and he stated "If you touch my car again, I have a gun" and the subject was told "Sir it doesn't have to go that far" to which the subject replied "It will, I have a gun in my car". The parking attendant, who is employed by a third party, stated that he was in fear for his life due to the recent phone calls made to the bank and the subject's aggressive behavior. The subject was located a short time later and interviewed by officers. Post Miranda per card, the subject provided a confession and a firearm was found in the subject's vehicle. The subject was arrested and transported to the TGK Jail Facility. A Risk Protection Order (RPO) was obtained.

Unknown subject(s) entered a vehicle parked in a condominium garage and stole a pair of sunglasses valued at \$700.00 dollars. There were no witnesses to the incident and an area canvass revealed no investigative leads.

HIGH HOLIDAYS

The Surfside Police Department has increased police presence with assigned details for high visibility during the High Holidays in the areas of The Shul 9540 Collins Avenue, Young Israel 9592 Harding Avenue, Hechal Shalom Sephardic Congregation 310 95th Street and Magen David Sephardic Congregation 9348 Harding Avenue. The enhanced patrols will be concentrated before and after services when congregants from the surrounding area and neighboring communities are walking to and from these locations. In addition, Bal Harbour and Bay Harbor Islands Police Departments will assign officers to further augment patrols in the area.

There will be uniformed security guards working at the Shul and Young Israel. The Shul will have three to five security guards working daily throughout the holidays. Young Israel will have one to four guards working daily throughout the holidays.
