CORONAVIRUS (COVID-19)

The Surfside Police Department has maintained situational awareness of the COVID-19 Pandemic Incident in coordination with Local, State, and Federal partner Agencies and through continued contact and information sharing with the Miami-Dade County Office of Emergency Operations-Emergency Operations Center. Our Department strives to maintain operational readiness, public preparedness, safeguarding the community, and enforcement of laws-ordinances-governmental orders. Our Department is aware that Continuity of Operations Plans especially regarding staffing is of paramount importance and therefore the Command Staff is considering several optional staffing models in the event police personnel are affected by COVID-19. Currently there are four (4) Sworn Officers that exhibited sign/symptoms that necessitated COVID-19 testing at a designated testing facility; three (3) Officers received a negative test result and returned to work, and one (1) Officer is awaiting the test results.

SIGNIFICANT INVESTIGATIONS/INCIDENTS

Gas Leak 03/17/2020 at 0935 hours 9300 block of Collins Avenue

SPD officers and Miami-Dade Fire Rescue responded to a gas leak caused by a small natural gas line accidentally struck during construction work. Traffic lanes on Collins Avenue and Harding Avenue were closed for public safety. MDFR Hazmat responded along with TECO Peoples Gas. The gas line was shut off and repairs were made by TECO Peoples Gas. Two westernmost lanes on the 9300 block of Collins Avenue were closed for approximately 55 minutes. The lanes were reopened once TECO Peoples Gas and MDFR deemed the area safe.
