# OFFICER OF THE MONTH - NOVEMBER 2020 - OFFICER TAMMY CAMPBELL

On November 12, 2020, the Surfside Police Department received a call from the Miami-Dade Police Department Communications Unit regarding a juvenile in crisis. The juvenile who was home at the time had been communicating with one of her teachers via text message and made comments saying she wanted to hurt herself. Officer Campbell responded to the home and made contact with the parents who were not aware of what their daughter was texting messaging to one of her teachers.

Officer Campbell quickly assumed the lead on this extremely delicate and serious situation. Officer Campbell met with the juvenile, determined she needed help and that this was not the first time she had feelings of doing harm to herself. Officer Campbell utilized her experience as a veteran police officer, training, years of developing CIT (crisis intervention team) skills and her motherly instincts to establish trust and established a good rapport with the juvenile in crisis. This led to the juvenile feeling comfortable and safe with Officer Campbell. Understandably, these situations are extremely difficult for the parents of the child and Officer Campbell again exhibited true professionalism and compassion in assisting them through a very trying occasion.

Due to Officer Campbell's professionalism and skills, she was able to connect with the juvenile and provided the help needed. Officer Campbell is commended for her actions in preventing a very serious situation from possibly becoming tragic. #### SIGNIFICANT INVESTIGATIONS/INCIDENTS

Motor Vehicle Theft 11/05/2020 at 1027 hours 9100 block of Collins Avenue

A vehicle containing personal items and construction equipment inside (valued at \$6,500.00 dollars) was taken from a parking garage. The vehicle was entered as stolen in the local/national database. A license plate reader check for the vehicle tag revealed a hit in the area of 1490 NE 160<sup>th</sup> Street in North Miami Beach. Later that evening, North Miami Beach PD recovered the vehicle in the area and the owner was notified.



Burglary to Motor Vehicle 11/09/2020 at 1702 hours 9400 block of Bay Drive

Unknown subject(s) entered a vehicle by smashing the rear passenger door window. A black suitcase containing \$200,000.00 dollars' worth of jewelry was taken from the floorboard. Surfside Police Department's Crime Scene Technician responded and processed the scene.

Grand Theft of Motor Vehicle 11/15/2020 at 1114 hours 1100 block of 88<sup>th</sup> Street

A rental vehicle was parked in front of the garage of a residence on November 13<sup>th</sup>, 2020. Upon return of the victim on November 15<sup>th</sup>, 2020, the vehicle was discovered missing. The vehicle was unlocked with the key fob inside. There were no personal belongings inside the car. Ongoing Investigation.

Grand Theft Motor Vehicle Arrest 11/17/2020 at 1842 hours 9449 Collins Avenue- Grand Beach Hotel

A hotel employee noticed his keys were missing from the top of his desk, checked on his vehicle and discovered it was missing. Surveillance video captured the subject walking into the building garage, entering the victim's car, and exiting the garage in the car minutes later. All surveillance footage was forwarded to detectives and a License Plate Reader (LPR) check revealed that the vehicle last traveled north on Collins Avenue, in Bal Harbour, at 1459 hrs. LPR again showed the vehicle traveling in the City of Doral at approximately 1600 hrs. On November 18<sup>th</sup>, 2020, at approximately 0700 hrs., the Doral Police Department recovered the stolen vehicle and arrested the male driver for grand theft of a motor vehicle. A Surfside Police Department Detective and Crime Scene Technician responded, processed the vehicle, and recovered the victim's belongings from the vehicle. The victim was notified and all items belonging to him were returned. SPD also charged the subject with burglary to a structure.

9200 Collins Avenue - Residence Inn by Marriott

On Friday, November 27, 2020, unknown subject(s) entered a hotel room and took a Louis Vuitton briefcase (valued at \$4,000 dollars) and its contents (valued at \$2,101.00 dollars). The victim had left the hotel room unlocked, using the open deadbolt as a door stop, due to religious reasons. At approximately 1700 hours, he returned and closed the door properly. The victim did not realize the briefcase missing until the following day.

Unknown subject(s) entered a vehicle by smashing the passenger window. The glove compartment and center console compartment were found opened and empty.
