The Honor Guard is a ceremonial unit comprised of sworn members of the police department who maintain an impeccable appearance, high moral standards, discipline and serve as the official representatives of the Surfside Police Department. The primary role of the unit is to provide funeral honors for fallen police officers that have given their lives while protecting our civil liberties and freedom. Honor Guard officers must have the strength to withstand overwhelming emotions when they're called upon to serve in times of tragedy.

Each year, the Honor Guard performs in dozens of high visibility and high profile ceremonies in Miami-Dade County and throughout Florida proudly representing the Surfside Police Department as members of multijurisdictional Honor Guard Teams. The Honor Guard is comprised of Sergeant Alejandro Lorente and Officers Ronald Donoso, Juan Duran, Marianne Howard, Bryant Luke, and Andres Mendoza. Sergeant Lorente oversees the Honor Guard coordinating which officer(s) will participate in the momentous events. Officer Howard contributes a unique service to this team and ceremonial events, she sings and performs a beautiful rendition of the National Anthem.

Sergeant Lorente and Officers Donoso, Duran, Howard, Luke, and Mendoza also perform ceremonial duties at special events such as the Town of Surfside Parks and Recreation Department's annual Memorial Day and Veterans Day events. Members of the honor guard also participate in National Police Week which takes place yearly in May, the month where the Nation celebrates Memorial Day and National Police Appreciation Month. This event has grown into a series of events which attracts thousands of survivors and law enforcement officers to our Nation's Capital each year. The members of this team have traveled to Washington, D.C. to be a part of this meaningful event as well as honor the men and women of law enforcement at a local level. Arson

Officers responded to a fire alarm call observing heavy smoke coming out of the building. The residents of the building were evacuated with no injuries reported. Miami-Dade Fire Rescue arrived on scene extinguishing the fire. It was determined the fire was contained to one unoccupied apartment and no structural damage occurred to the building. The resident of the apartment arrived on scene and advised officers that he was burning his clothes because he did not want anyone to know who he was. The resident was taken into custody and arrested. Miami-Dade Police Department's Arson detective responded and will conduct the investigation.

Unknown subject(s) entered an unlocked vehicle parked in the driveway of a residence on 11/26/2021. Officers responded to a call of an assault. The residents of an apartment, who are a female and male couple, reported that a neighbor became upset because they were hammering a nail in the wall. The neighbor began yelling from his apartment and then entered the couple's apartment to confront them without consent. During the dispute, the neighbor was repeatedly told to leave but refused grabbing the male by the neck. The female attempted to intervene sustaining bruising to her neck. The neighbor was subsequently arrested.

POLICE DEPARTMENT RE-ACCREDITATION ONSITE ASSESSMENT

The Police Department's onsite Re-Accreditation assessment will take place December 7th ,8th and 9th, 2021. We are seeking Re-accreditation status for the fourth consecutive cycle having achieved the prestigious initial Commission for Florida Law Enforcement Accreditation (CFA) in 2009. A team of CFA assessors will examine all aspects of the Surfside Police Department's policies and procedures, management, operations, and support services. The Police Department has to comply with more than 250 standards in order to receive reaccredited status. Many of the standards are critical to life, health, and safety issues.
