Rule 7.05 Decorum. Any person making impertinent or slanderous remarks or who becomes boisterous while addressing the commission shall be barred from further appearance before the commission by the presiding officer, unless permission to continue or again address the commission is granted by the majority vote of the commission members present. No clapping, applauding, heckling or verbal outbursts in support or opposition to a speaker or his or her remarks shall be permitted. Signs or placards may be disallowed in the commission chamber by the presiding officer. Persons exiting the commission chambers shall do so quietly.

Rule 6.05 Agenda. The good and welfare portion of the agenda set for 8:15 p.m. shall be restricted to discussion on subjects not already specifically scheduled on the agenda for discussion and debate. In no event shall this portion of the agenda be allotted more than 45 minutes with each speaker to be given no more than three minutes, unless by vote of a majority of the members of the commission present, it is agreed to extend the time frames. Likewise, commission members shall be restricted to speaking three minutes each unless an extension is granted in the same manner as set forth in the prior sentence.

Any person who received compensation, remuneration or expenses for conducting lobbying activities is required to register as a lobbyist with the Town Clerk prior to engaging in lobbying activities per Town Code Sec. 2-235. "Lobbyist" specifically includes the principal, as defined in this section, as well as any agent, officer or employee of a principal, regardless of whether such lobbying activities fall within the normal scope of employment of such agent, officer or employee. The term "lobbyist" specifically excludes any person who only appears as a representative of a not-for-profit corporation or entity (such as charitable organization, a trade association or trade union), without special compensation or reimbursement for the appearance, whether direct, indirect, or contingent, to express support or opposition to any item.

Per Miami Dade County Fire Marshal, the Commission Chambers has a maximum capacity of 99 people. Once reached this capacity, people will be asked to watch the meeting from the first floor.

1. Opening

A. Call to Order

Mayor Dietch called the meeting to order at 7:02 p.m.

B. Roll Call of Members

Town Clerk Sandra Novoa called the roll with the following members present: Mayor Daniel Dietch, Commissioner Tina Paul, Commissioner Michael Karukin and Commissioner Daniel Gielchinsky. Vice Mayor Barry Cohen was absent.

Commissioner Gielchinsky made a motion to allow Vice Mayor Cohen to participate by phone. After passing the gavel, the motion received a second from Mayor Dietch. Commissioner Gielchinsky made a motion to discuss. The motion received a second from Commissioner Karukin.

Town Manager Olmedillo read into the record a correction on page 87 as there was an incomplete sentence.

The Commission discussed the ordinance and had some issues with it. They also had some concerns regarding renovations to single family homes. Manager Olmedillo and Building Official Ross Prieto offered more insight regarding their issues.

Mayor Dietch opened the public hearing.

Public Speakers:

- -Victor May was not in favor of the ordinance and explained why he felt so.
- -George Kousoulas felt the basis of the ordinance is good but suggests they do not make it too complicated.

The Commission further discussed fees, permits, audits and the Flood Insurance Program. Regarding the ordinance, the Commission agreed in part but felt the ordinance needed further refinement.

Commissioner Karukin made a motion to defer the item till November Commission Meeting 2016. The motion received a second from Commissioner Paul and all voted in favor.

AN ORDINANCE OF THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA AMENDING ARTICLE II "LOCAL BUSINESS TAX RECEIPT" OF CHAPTER 70 "TAXATION" AND SPECIFICALLY AMENDING "SECTION 70-41 "LOCAL BUSINESS SCHEDULE" TO **INCLUDE BEACH FURNITURE OPERATION**; **AMENDING CHAPTER** 86 "WATERWAYS"; ARTICLE II, "PUBLIC BEACHES", SPECIFICALLY AMENDING SECTION 86-26 "DEFINITIONS"; CREATING SECTION 86-30 "BEACH FURNITURE"; CREATING SECTION 86-31 "BEACH PERMIT": **FURNITURE** CREATING **SECTION** 86-32 "INDEMNIFICATION AND INSURANCE"; CREATING SECTION 86-33 "VIOLATIONS, CIVIL **FINES AND** PENALTIES"; PROVIDING FOR INCLUSION IN THE CODE: REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH: AND PROVIDING FOR AN EFFECTIVE DATE.

Town Clerk Sandra Novoa read the title of the ordinance Town Manager Olmedillo presented the item.

Commissioner Gielchinsky made a motion to discuss. The motion received a second from Commissioner Karukin.

The Commission briefly gave their views on the ordinance with some suggestions.

Mayor Dietch opened the public hearing.

Public Speakers:

- -Victor May feels there should be an agreement between all parties as it is a public beach and regulated by State.
- -Jeffery Platt is against beach chair operators taking up beach space leaving little for the public.
- -George Kousoulas believes the ordinance needs more work.
- -Joel Simmonds representing Grand Beach Hotel had issues with the ordinance and read the language he was not in favor of.
- -Deborah Cimadevilla had a visual presentation showing rows of unused chairs and storage on the beach. A motion was made to allow Ms. Cimadevilla to speak an additional minute.
- -Michael Kashdan representing the Surf Club believes there should be an individual management plan for each property. A motion was made to allow Mr. Kashdan to speak an additional minute.
- -Clara Diaz-Leal is happy that they are working on an ordinance and having an individual management plan is essential.
- -Amy Huber an attorney representing the Surf Club said the ordinance needs some changes as they are not in favor as it is written. A motion was made to allow Ms. Huber to speak an additional minute.
- -Terry Cohen suggested all parties meet to come to a solution.

Commissioner Paul gave a power point presentation showing the history of the beach from years ago to present. She suggests tailoring to each property as they are different but is against commercialization. The Mayor wanted it clear that the absence of regulation gives us no influence as to what happens on the beach. Commissioner Karukin believes we should proceed without fear of litigation and agrees with an individualized management plan. Commissioner Gielchinsky agrees we should have an individualized management plan but feels we would not be allowed to do so. He also brought up funding and where the money will come from. Commissioner Karukin believes it could come from the Tourist Board revenue.

Passing the gavel, Mayor Dietch made a motion to amend Section 86-33 and to incorporate (1) legislation to be reviewed in one year; (2) permits are revocable; (3) administrative policies regarding public access and safety (4) beach furniture storage (5) adequate staffing; (6) area cleaning; (7) set-up procedures; (8) designated area for public health, safety and welfare. The Town Manager is directed to bring back a finance plan by second reading. The motion received a second from Commissioner Gielchinsky. Commissioner Paul made a friendly amendment that there be no beach commercialization such as renting of beach chairs but hotels provide chairs as an amenity and condos provide chairs as needed. The Mayor accepted the friendly amendment but Commissioner Gielchinsky did not accept the friendly amendment. Passing the gavel, the Mayor restated the motion and added that condos will place chairs as needed and hotels will have a preset and provide chairs as an The motion received a second from Vice Mayor Cohen. The motion passed 3/2 with Vice Mayor Cohen and Commissioner Gielchinsky voting in opposition.

Commissioner Karukin made a motion to approve. The motion received a second from Commissioner Gielchinsky and all voted in favor with Vice Mayor Cohen absent for the vote.

Vice Mayor Cohen was disconnected at 10:46p.m. and called back at 10:50 p.m.

Commissioner Karukin made a motion to approve. The motion received a second from Commissioner Gielchinsky and all voted in favor.

Town Clerk Sandra Novoa read the title of the resolution. Town Manager Olmedillo presented the item.

Commissioner Karukin made a motion to approve. Commissioner Gielchinsky made a friendly amendment that we wave the vacation for the Town Manager. Commissioner Karukin accepted the amendment. The motion received a second from Commissioner Paul and all voted in favor.

Public Speaker Victor May spoke on the item and suggested the Town Manger was in a conflict of interest. Mayor Dietch responded and to clarify for the record, the provision in the contract related to conflict of interest were for those entities that he may have worked for in the past. As to the present the Town Manager was very clear about his business and this was presented to our employment lawyer and this is a legal provision. The Commission spoke highly of the Town Manager.

Commissioner Karukin made a motion to extend the meeting one hour. The motion received a second from Commissioner Gielchinsky. The motion passed 4/1 with Commissioner Paul voting in opposition.

Public Speakers:

- -Clara Diaz-Leal spoke about timeline, previous lots proposed and giving back the money for the parking spots we sold and do not have.
- -Jeffery Platt spoke about the Town Hall lot and was against the Abbott lot and feels we do not need more parking lots.
- -George Kousoulas recommended the study and suggested a mini garage.
- -Deborah Cimadevilla asked if a referendum was needed.

Commissioner Paul left the meeting at 11:44 p.m.

At 11:56 p.m. Commissioner Gielchinsky made a motion to extend the meeting 15 more minutes. The motion received a second from Commissioner Karukin and all voted in favor with Commissioner Paul absent.

Commissioner Gielchinsky made a motion to direct the Town Manager to provide a summary of steps taken; a brief summary of parking studies; a summary of potential sites as well as negotiating of potential sites to include a recap of development agreements that utilize the parking trust fund, the number of spots and the financial commitment made including dollar amount and years of commitment and if there was an out clause; provide high level options and what courses of action we can take next.

The motion received a second from Mayor Dietch after passing the gavel. The motion passed with all voting in favor with Commissioner Paul absent.

Commissioner Gielchinsky made a motion to extend the meeting 15 minutes. The motion received a second from Commissioner Karukin. The motion passed with all voting in favor with Commissioner Paul absent.

6. Good and Welfare

Mayor Dietch opened the meeting to Good and Welfare.

Public Speakers:

- -George Kousoulas suggested using Sarah Sinatra and her services in helping with some of the ordinances that come before the Planning and Zoning Board and Commission.
- -Lou Cohen spoke about people at home having the ability to contact the Board or Commission to participate by video.
- -Terri Cohen spoke about undergrounding of utilities which she is in favor of.

- -Jeffrey Platt spoke about the future of the town and about the construction workers and parking issues.
- -Nick Wigoda spoke in favor of undergrounding utilities as well as sidewalks and streetscape.
- -Eli Ginsberg was in favor of undergrounding utilities but was concerned about the financial burden it may cause especially for people on fixed incomes.
- -Sanjay Kamlani supports undergrounding utilities. He suggested that the money being generated from new construction be used to beautify the town.
- -Victor May spoke about safety and security and gating the community.
- -Deborah Cimadevilla spoke about undergrounding utilities and said it is not feasible in areas prone to flooding such as the area in which she resides. The issue of flooding must be resolved first.

Commissioner Karukin addressed the issue of undergrounding utilities and feels with new technology it is something they should look in to. However, he mentioned it will be very costly. On the issue of flooding he read some suggestions such as making sure storm drains are cleared of debris. Commissioner Gielchinsky also addressed the issue of underground utilities and thanked the people who attended to voice their opinions. Commissioner Paul spoke about the community changing and is looking for a balance of life. She understands Mr. Ginsburg's concerns about who is going to pay for the undergrounding of utilities and hookups to residences. Flooding on some of our streets was also mentioned. Mayor Dietch gave an overview of what has been done regarding flooding. He also addressed the other issues of concern by the public.

No one else wishing to speak the Mayor closed Good and Welfare.

Subject:

Zoning In Progress – Regulating Medical Marijuana Facilities

The Town Administration of the Town of Surfside has determined that it is in the best interest of the Citizens of Surfside and the general public to regulate the location of medical marijuana facilities in the event the State of Florida legalizes said facilities for medical use. The Town has seen reports, studies and cases regarding the impacts of medical marijuana facilities to the surrounding area. The Town Commission has the authority to determine what uses are best suited to particular zoning categories as well as land use categories within the Town.

Pursuant to Florida law, Compassionate use of low-THC and medical cannabis.—

"A municipality may determine by ordinance the criteria for the number and location of, and other permitting requirements that do not conflict with state law or department rule for, dispensing facilities of dispensing organizations located within its municipal boundaries. A county may determine by ordinance the criteria for the number, location, and other permitting requirements that do not conflict with state law or department rule for all dispensing facilities of dispensing organizations located within the unincorporated areas of that county." Section 381.986(8)(b) Fla. Stat.

To address the situation of potential new medical marijuana facilities in the Town in locations that are inconsistent with proposed zoning changes, the Town may invoke "Zoning in Progress," as provided by Sec. 90-6 of the Code of Ordinances. The "Zoning in Progress" doctrine generally allows the Town to temporarily "pause" the processing of applications while new zoning regulations are being prepared for adoption, if the new application will be affected by the anticipated changes in zoning regulations. Pursuant to Sec. 90-6(3) of the Code of Ordinances Zoning in Progress, the Town will stop the review of any application while code modifications are being considered, from the time of the publication of notice of the intent to pursue new regulations until the regulations are adopted or three months from now, whichever occurs first.

Recommendation: Direct the Town Clerk to publish a Notice of Zoning in Progress as provided in Section 90-6 "Zoning in Progress" of the Code of Ordinances, in order to apply a hold on the processing of applications that are submitted to the Town after the date of the publication of the Notice.
