

Town of Surfside Regular Town Commission Meeting MINUTES December 12, 2023 6:00 PM

1. Opening

1A. Call to Order

Mayor Danzinger called the meeting to order at 6:09 p.m.

1B. Roll Call of Members

Town Clerk McCready called the roll with the following members present.

Present: Mayor Shlomo Danzinger, Vice Mayor Jeff Rose, Commissioner Fred Landsman, Commissioner Marianne Meischeid and Commissioner Nelly Velasquez (absent from the dais but in the building) (arrived back to the dais at 6:10 p.m.).

Also Present: Town Attorney Lillian Arango, Town Attorney Tony Recio, and Town Manager Hector Gomez.

1C. Pledge of Allegiance

Interim Chief Marciante provided the pledge of allegiance.

1D. Mayor and Commission Remark - Mayor Shlomo Danzinger

Mayor Danzinger welcomed everyone presented and watching from home. He wished his wife a happy anniversary. He reminded everyone present about the decorum statement and conduct during the meeting. He went over the different events that have taken place and are upcoming.

Commissioner Landsman congratulated the Mayor and his wife on their anniversary. He congratulated the Town Manager for the birth of his second daughter. He wishes everyone a happy holiday season.

Commissioner Meischeid hopes everyone had a happy thanksgiving. She gave thanks for being able to serve the community and she will not be returning for the upcoming election and there are great candidates running for commission and wishes them good luck. She will be asking her fellow commissioners to reconsider

the outdoor lighting ordinance because she was not at the meeting when it came up due to her being sick.

Commissioner Velasquez thanked everyone for being here. She wishes everyone a great holiday season.

Vice Mayor Rose thanked everyone watching from home and wished everyone a happy holiday. He gave a great shout out to the Public Works staff for their hard work and the community service aide for the incredible work being done. He stated that several residents asked why Commissioner Velasquez walked off the dais at the last meeting and explained the reason she walked out was because he lied about voting on the November 7 election. He stated there is an investigation into this and against her.

Mayor Danzinger passed the gavel.

Mayor Danzinger would like for item 9A (Permit Fees for Condominium Recertification and Special Assessments) and item 9C (Additional Discussion for Retaining Wall Standards and On-site Containment of Stormwater) after item 2 (Quasi-Judicial Hearings); add a new item to be new item 3J (Update on Investigation against Commissioner Nelly Velasquez) to be heard after item 3 (Consent Agenda); add a new item to be new item 3K (Anti-Semitism in the Town of Surfside) to be heard after item 3J (Update on Investigation against Commissioner Nelly Velasquez); add a new discussion item to be new item 9E (Point Lake), item 9F (Donation to Ruth K. Broad) to be heard at the end of the discussion items and then add a new item 7C (Executive Session) to be heard after item 7B (Town Attorney's Report).

A motion was made by Vice Mayor Rose to walk on an item to be heard before Item 3 (Consent Agenda) making it new item 3J (Update on Investigation against Commissioner Nelly Velasquez), seconded by Commissioner Landsman. The motion carried with a 4-1 vote with Commissioner Meischeid voting in opposition.

A motion was made by Commissioner Velasquez to move item 9F (Donation to Ruth K. Broad) to be heard after item 9A (Permit Fees for Condominium Recertification and Special Assessments) and item 9C (Additional Discussion for Retaining Wall Standards and On-site Containment of Stormwater) and add the reconsideration of the light ordinance as first reading ordinance new item 4B3 (Light Ordinance Reconsideration), seconded by Commissioner Meischeid. The motion carried with a 4-1 vote with Mayor Danzinger voting in opposition.

A motion was made by Commissioner Meischeid to have the reconsideration of the light ordinance added as first reading to be new item 4B3 (Light Ordinance Reconsideration), seconded by Commissioner Velasquez. The motion carried with a 3-2 vote with Mayor Danzinger and Vice Mayor Rose voting in opposition.

Mayor Danzinger introduced the item.

Mayor Danzinger opened up the floor to public comment.

Mayor Danzinger closed the floor to public comment.

A motion was made by Mayor Danzinger to give a key to the Town, a presentation and proclamation to those elected officials that have served three (3) consecutive terms, seconded by Vice Mayor Rose.

Mayor Danzinger explained that there needs to be some sort of limitation.

Commissioner Landsman agrees with the Mayor.

Commissioner Meischeid would like to eliminate the word consecutive and reconsider also 2 terms.

Commissioner Velasquez stated this is another example of this Mayor trying to divide our Town. She also does not agree with the 3 consecutive years of service.

The motion carried with a 3-2 vote with Commissioner Meischeid and Commissioner Velasquez voting in opposition.

3J.) Update on Investigation against Commissioner Nelly Velasquez

Commissioner Velasquez stated that this is a political ploy.

Town Manager Gomez asked Commissioner Velasquez to stop addressing Town employees and making those statements. He provided a summary of the investigation and per their procedure they are required to bring it forth to this body. He stated that they are in the last part of the investigation and there is a scheduled interview with the last

individual scheduled for tomorrow, December 13, 2023. If that interview does not take place and is cancelled they will move forward to conclude the investigation.

Mayor Danzinger asked Town Manager Gomez how many times this individual has had the opportunity to meet with this investigator and then cancelled her interview appointment in the last three months.

Commissioner Velasquez told Town Manager Gomez to not lie and it has only been once.

Town Manager Gomez stated that he is would not lie and that it has been a few attempts to coordinate a meeting.

Commissioner Velasquez stated that coordinating a meeting and having the meeting are two different things.

Mayor Danzinger stated that 3 months is long enough to coordinate and all of them made the time to go and give their testimony.

A motion was made by Mayor Danzinger to direct the Town Manager that if the Commissioner does not take the time to cooperate with the investigation that the administration ask the investigator to conclude his investigation and bring forward an item on the January 9, 2024 commission meeting agenda, seconded by Vice Mayor Rose.

Commissioner Velasquez stated this is for political purposes and using Town funds for political purposes.

Town Manager Gomez stated that there is a formal complaint filed and they are following the process laid out in their policy.

Commissioner Velasquez continued to interrupt and called the employee that filed the complaint "insubordinate".

Vice Mayor Rose asked if this investigation is being done by the Town or a third party.

Town Manager Gomez stated it is being conducted by a third party. He stated they need to conclude this investigation. This complaint was filed by an employee for a hostile work environment and they need to investigate this further. He cannot provide more information because it is an open investigation. He stated the sooner they are able to close it the sooner they can have it available.

Commissioner Velasquez continued to state that this is for political purposes and they are inpatient.

The motion carried with a 3-2 vote with Commissioner Meischeid and Commissioner Velasquez voting in opposition.

3K.) Anti-Semitism in the Town of Surfside

Mayor Danzinger introduced the item and spoke regarding the attack on Israel and what the purpose of this is and there is a strong voice saying that this is made up. He stated

that he will spare them from the gruesome video he has watched. He stated that the worse thing is that some people are trying to silence what happened. He stated when you condone the actions of terrorists, there is no reason to make an excuse of their actions. He called out Commissioner Meischeid for sending out multiple emails to rally people against the posters that were sent out and being an antisemite.

Due to the extreme yelling among some of the members of the commission, minutes were unable to be taken of this section.

A motion was made by Mayor Danzinger to direct the Town Manager to support and allow the private entities to put the posters on their property, seconded by Vice Mayor Rose. The motion carried with a 3-2 vote with Commissioner Velasguez and Commissioner Meischeid voting in opposition.

Mayor Danzinger requested to add the emails he has as proof of Commissioner Meischeid's antisemitic comments as part of the record and made part of the minutes.

Town Manager Gomez introduced the item.

Town Attorney Arango provided an overview of the ordinance.

Mayor Danzinger opened up the floor to public comments.

There were no public speakers.

Mayor Danzinger closed the floor to public comment.

A motion was made by Vice Mayor Rose to approve the ordinance on first reading, seconded by Commissioner Landsman. The motion carried with a 5-0 vote.

4B2. Ordinance Amending Chapter 54 - Offenses and Miscellaneous Provisions -Hector Gomez, Town Manager

The City of Miami Beach recently fortified the safety and well-being of its residents

and visitors by amending Chapter 70 of the City Code, specifically Article II titled "Public Places," under Section 70-45, which now prohibits camping.

The Town Commission should consider adopting the attached ordinance enacting regulations to oversee and restrict specific activities or conduct in public areas that obstruct access, jeopardize safety or sanitation, or infringe upon the public's rights to freely utilize these spaces for their intended purposes. This is essential for safeguarding the health, safety, and well-being of both Town residents, visitors and the public.

Town Clerk McCready read the title of the ordinance into the record.

Town Manager Gomez introduced the item.

Town Attorney Arango provided an overview of the ordinance.

Mayor Danzinger opened up the floor to public comments.

The following individuals from the public spoke: Eliana Salzhauer spoke against the ordinance.

Mayor Danzinger closed the floor to public comment.

Mayor Danzinger provided an overview of the ordinance and what it will entail and the tools it will give the police department to enforce the law and ask them to leave the property.

Commissioner Velasquez asked regarding cooking on an open flame.

Mayor Danzinger explained what that section means, and you can cook in your own private property.

Vice Mayor Rose asked how you determine someone camping from a friend staying over.

Town Manager Gomez addressed the question made by Vice Mayor Rose.

A motion was made by Vice Mayor Rose to approve the ordinance on first reading and to add the portion back in for second reading which is camping is prohibited on all private residential property with the exception of explicit consent from the property owner, seconded by Commissioner Landsman. The motion carried with a 5-0 vote.

Ordinance Amending Chapter 54-Offenses and Miscellaneous Provisions

4B3.) Light Ordinance Reconsideration

Town Clerk McCready read the title of the ordinance into the record.

A motion was made by Commissioner Meischeid for purposes of discussion, seconded by Commissioner Velasquez. The motion carried with a 5-0 vote.

Town Manager Gomez introduced the item and stated this item has been brought back tonight by Commissioner Meischeid for reconsideration.

Mayor Danzinger opened the floor to public comments.

The following individuals from the public spoke: George Kousoulas spoke in support of the item Eliana Salzhauer spoke in support of the item

Mayor Danzinger closed the floor to public comments.

Commissioner Meischeid introduced the item and explained the importance of having something in place. She would like to keep item c and e of the ordinance.

A motion was made by Commissioner Meischeid to revise the ordinance at first reading to strike out items a, b, d, f, g, h and i and only leave items c (not to include motion sensors and intermittent lighting) and e; for it to apply to new constructions and remodels; the light will not spill out into the neighbor's yard and take out the word 10 feet, seconded by Commissioner Velasquez.

Commissioner Landsman has a concern with item e because who determines this is not in harmony and suggested to clarify the language or make it more manageable.

Commissioner Meischeid asked if the Town Manager can work with the Town Planner on the language.

Town Planner Frankel explained who the Town Manager's designee would be and the process.

Mayor Danzinger addressed the comments regarding who would take this on and if they could task the appropriate person.

Vice Mayor Rose stated that the way it is currently written he cannot support it.

After a lengthy discussion on the specifics of this ordinance and verbiage, the vote was called, and the motion carried with a 5-0 vote.

5A. On-Demand Transit Services Through FREEBEE Ride Share - Hector Gomez, Town Manager

Town Administration is recommending proceeding to contracting with FREEBEE for on-demand transit transportation services funded through CITT funds for a total not to exceed \$131,760 per year with typical services occurring 7 days a week for a total

of 70 hours per week at a rate of \$36.20 per hour for a total of an initial term running from the Effective Date through April 25, 2025 (concurrent with the term on the City of Sunrise Contract), with two (2) additional one (1) year renewal periods.

Town Clerk McCready read the title of the resolution into the record.

Town Manager Gomez introduced the item.

Mayor Danzinger opened up the floor to public comments.

The following individual from the public spoke: Eliana Salzhauer

Mayor Danzinger closed the floor to public comment.

Discussion took place to have the Town Manager make sure the Freebee will be ADA compliant.

A motion was made by Commissioner Landsman to approve the resolution, seconded by Vice Mayor Rose. The motion carried with a 5-0 vote.

Town Manager Gomez stated they have an issue with CITT and they need to use the funds if not they will be requesting it back. He stated there are certain monies to be used for walkability and he would like to bring forward some sidewalk projects.

Mayor Danzinger opened the floor to public comments.

A motion was made by Commissioner Landsman to approve the Town Attorney's Report, seconded by Vice Mayor Rose. The motion carried with a 5-0 vote.

Town Attorney Report

7C.) Executive Session

Town Attorney Arango provided a summary of the lawsuit regarding <u>Schnabel Engineering</u>, <u>LLC</u>, <u>v. KCE Structural Engineers</u>, <u>P.C. and Town of Surfside</u>, <u>Case No. CL23-7597</u>, <u>Henrico County Circuit Court</u>, <u>Viriginia</u>. She explained that they need to hold the executive session on Monday, December 18, 2023 in the morning. She stated that they have to engage a law firm Sams Anderson PC a Virginia firm to represent the Town.

Town Manager Gomez stated the more immediate action is needed and they do need to have a shade session and direction to engage the firm.

Mayor Danzinger stated that it is not fair to have Mr. Kilsheimer to throw this urgency but

understands. He stated if Monday morning works for the commission.

Consensus was reached to hold the executive session for Monday, December 18, 2023, at 10:00 a.m.

A motion was made by Mayor Danzinger to direct the Town Manager to engage the law firm Sams Anderson PC for this lawsuit and file the motion and pay the retainer fee of \$3,000, seconded by Commissioner Landsman. The motion carried with a 5-0 vote.

9. Mayor, Commission and Staff Communications

9A Permit Fees for Condominium Recertification and Special Assessments - Commissioner Meischeid

Develop permit fees specific to condominium re-certification and special assessment that are not the same as applied for new construction in order to mitigate the increased cost of condominium re-certification and special assessments.

A motion was made by Commissioner Meischeid for purposes of discussion, seconded by Vice Mayor Rose. The motion carried with a 5-0 vote.

Mayor Danzinger opened the floor to public comments.

The following individual from the public spoke: George Kousoulas

Mayor Danzinger closed the floor to public comments.

Commissioner Meischeid provided an overview of the item and what is coming up with the condominiums including special assessments.

Building Official McGuinness spoke regarding the permit fees and how it would work with the Building Department.

Further discussion took place among the Commission and staff as to the possible process of the permit fees and requirements.

A motion was made by Commissioner Meischeid to direct the Town Manager to develop permit fees and have the building director come up with numbers to have ready for the next meeting, seconded by Commissioner Velasquez. The motion carried with a 5-0 vote.

9B. Town Manager Performance Evaluation - Mayor Shlomo Danzinger

Perform an evaluation of the Town Manager for the performance period and motion for any additional actions as a result of the evaluation.

Mayor Danzinger stated that per the Town Manager's contract they have to do his

performance evaluation.

A motion was made by Vice Mayor Rose for purposes of discussion, seconded by Commissioner Landsman.

Mayor Danzinger opened the floor to public comments.

There were no public speakers.

Mayor Danzinger closed the floor to public comments.

Vice Mayor Rose stated that the Town Manager has done an amazing job and the people he has put around him has been great. He is the single most important thing, and he is the heart and engine of this town.

Commissioner Landsman spoke regarding the comments from his counterparts, and it is unfortunate that a couple of members of this commission decided to make it a political discourse as part of his evaluation and he is disappointed. He stated he has done a great job in taking on the responsibilities without any lead time and we wouldn't be today where we are without his help.

Commissioner Meischeid stated that her evaluation is her prerogative. She stated that this is Mr. Gomez' first year in his new position and he has put a lot of energy into this new position. She stated his weakness have been addressed with him directly.

Commissioner Velasquez stated her evaluation was based on her knowledge of the Town Manager and what she has observed. She stated he needs to enhance his negotiation skills.

Discussion regarding a previously discussed item commenced regarding emails from Commissioner Meischeid to Town Manager Gomez and anti-semitic comments by Commissioner Meischeid.

Town Manager Gomez stated that he did not provide anyone with emails and if someone does a public records request. He does not share anything with anyone, and he is here to do a job and he would appreciate for the commissioners to not accuse him of something that he has not done.

Mayor Danzinger stated this is extremely personal for this Commissioner (Commissioner Velasquez) because she is under investigation. He also stated it is incredible that Commissioner Velasquez never filled out an evaluation for the former manager, Andrew Hyatt. He stated that he has had the privilege of being here most of the time and he gets to see Town Manager Gomez' work daily and he is fortunate to work with him. He read his comments into the record "With a background in public works, the Town Manager possess valuable technical knowledge that provides a significant advantage in planning and overseeing capital improvement projects, negotiating with external vendors, and addressing resident concerns. His creative problem-solving skills have not only led to effective solutions but have also resulted in substantial cost savings for the Town. Remarkably, he successfully balanced the

Solid Waste and Water funds, achieving this milestone ahead of the initially projected five-year timeline. Additionally, his effective management abilities have boosted employee morale, creating a positive work atmosphere and ensuring a cohesive and motivated team. This has led to enhanced staff engagement, increased creative thinking, and greater employee retention".

Vice Mayor Rose addressed comments made by Commissioner Velasquez which are inaccurate.

Mayor Danzinger stated the Manager wanted to adjust some of the benefits choices and package.

Vice Mayor Rose is comfortable with a 5% raise and to discuss the 401K benefits.

Town Manager Gomez stated that at the time of the original contract he did not have time to look at the benefits because of the urgency of filling the position. He would like to choose the 401K benefits as a pension plan. He addressed the comments made by the commissioners.

Commissioner Landsman thanked Mr. Gomez for everything he has done for the Town.

If signs displayed on construction fences are non-code compliant, then the signs currently on display are in violation. Is the owner of the site being fined?

The administration cannot pick and choose based upon the content of the signage.

In addition, let's not continue the "confusing" rationale epitomized by the mayor 's statements regarding the Pride flag.

In the May 23, 2023 edition of "Miami New Times" in an article entitled Surfside Mayor Pooh-Poohs Idea for Town-Sponsored Gay Pride Event, the mayor said " ... what I did not support was the use of our government flagpole to promote a specific message without a town policy in place that would grant equal opportunities to all organizations."

Certainly, an Israeli flag illuminated in a window at Town Hall amounts to a government display.

The same article continues "While explaining his reasoning at a March 14 commission meeting, Danzinger used some rhetorical arguments that caught attendees off-guard. As CNN.com noted in a June 30, 2021 article entitled "The Mexican rescuers joining the search for survivors in Surfside": Rescue specialists from Mexico are joining the massive search for survivors in the wreckage of the Surfside, Florida partial building collapse. In the disaster zone, assisting local, state and federal rescue crews, is the Mexico-based "Go Team" of Cadena International, a Jewish nonprofit which has responded to more than 1,000 natural

disasters and humanitarian crises since 2005. Another rescue team from Mexico on the scene, "Topos Azteca," is a non-profit Mexican group founded after the deadly 1985 Mexico City Earthquake, who are known as experts in massive search and rescue operations around the world."

Wikipedia confirms that "On June 25, Mayor Levine Cava announced that rescue teams from Israel and Mexico had joined the search and rescue effort, rotating in two daily 12-hour shifts of sifting through the rubble."

And yet...no mention of Mexico, ever.

There have been four significant earthquakes In Mexico during 2022. And silence from Surfside.

Let's try to return to the time when elected officials advocated on behalf of ALL Surfsiders.

I agree with an observation of the reporter in the May 20, 2023 Miami New Times article: "One might think that special events that celebrate a particular culture or demographic would support Danzinger's mission. But in the mayor's mind, these are implements of exclusion and run the risk of alienating residents and making people feel like they don't belong."
