# A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, ADOPTING THE FINAL MILLAGE RATE FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2021 AND ENDING SEPTEMBER 30, 2022; ANNOUNCING THE ADOPTED FINAL MILLAGE RATE OF 4.2000 MILLS WHICH IS GREATER THAN THE ROLLED BACK RATE OF 4.1046 MILLS COMPUTED PURSUANT TO STATE LAW BY 2.32\%; AND PROVIDING FOR AN EFFECTIVE DATE. 

WHEREAS, pursuant to Section 200.065, Florida Statute the Miami-Dade County Property Appraiser ("Property Appraiser") has certified the tax e va within the Town of Surfside (the "Town") for the year 2021, which includes all re?"prof ty y thin the Town; and

WHEREAS, on September 13, 2021, the Town Con ssio held its first budget public hearing and adopted Resolution No. 2021-2808 settip the prop d millage rate at 4.2000 mills for the fiscal year commencing October 1, 2021; and

WHEREAS, the Town Commission find thy necessary to levy and adopt a final ad valorem millage rate in the Town; and

WHEREAS, the Town Co proposed Fiscal Year 2021/2022
sio ar the Town Manager have reviewed the Town's mep contemplated for in the Bud ct, ana ave determined that the final millage rate levy set forth below provides the necessa, fi ds frr such expenditures.

NOW, THF EF RE, GE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SUh SIDE, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. That the above-stated recitals are hereby adopted and confirmed.

Section 2. Adopting Final Millage Rate. The final millage rate to be levied for the Town of Surfside for the fiscal year commencing October 1, 2021 and ending September 30, 2022 is hereby fixed and adopted at 4.2000 mills per $\$ 1,000.00$ of assessed property value.

Section 3. Announcing Percentage Increase. The proposed millage rate of 4.2000 mills is greater than the rolled-back rate of 4.1046 mills computed pursuant to Section 200.065, Florida Statutes by $2.32 \%$, which is the percentage increase in property taxes.

Section 4. Effective Date. That this Resolution shall become effective immediately upon adoption.
