

RESOLUTION NO. 2025-3369

**A RESOLUTION OF THE TOWN OF SURFSIDE, FLORIDA,
RESCINDING ITS APPROVAL OF A CONTRACT WITH
DUSTLESS BLASTING LLC, FOR BEAUTIFICATION AND
SIDEWALK IMPROVEMENT PROJECT ON HARDING
AVENUE, BUSINESS DISTRICT (RESOLUTION NO. 2025-
3364); PROVIDING FOR IMPLEMENTATION; AND
PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, the Town of Surfside (the "Town") desires to rescind its approval of the contract with Dustless Blasting, LLC ("Contractor") for the performance of certain sidewalk improvements on Harding Avenue, within the Business District, from 94th to 96th Street, using a sandblasting method (the "Work") for an amount not to exceed \$92,000.00 (Resolution No. 2025-3364); and

WHEREAS, the Town Commission passed Resolution No. 2025-3364 on January 14, 2024;

WHEREAS, the Town seeks to explore alternative options to create and design new sidewalks within the Business District;

WHEREAS, the Town has communicated with the Florida Department of Transportation ("FDOT") regarding its maintenance responsibilities of the sidewalks in the Business District, which is on a state roadway for which FDOT has exclusive jurisdiction;

WHEREAS, the Town recognizes additional time is required to explore such options prior to committing the Town's resources to the desired sidewalk improvements; and;

WHEREAS, the Town Commission finds that it is in the best interests of the Town to immediately rescind its approval of Resolution No. 2025-3364.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE
TOWN OF SURFSIDE, FLORIDA AS FOLLOWS:**

Section 1. Recitals. The above recitals are true and correct and incorporated herein by this reference.

Section 2. Action. The Town Commission hereby rescinds its approval of the proposed contract with Contractor, as set forth in Resolution No. 2025-3364.

Section 3. Implementation. The Town Mayor and Town Officials are hereby authorized to take any and all actions which are necessary to implement the purposes of this Resolution.

Section 4. Effective Date. This Resolution shall take effect immediately upon adoption.
