A RESOLUTION OF THE TOWN OF SURFSIDE, FLORIDA, RESCINDING ITS APPROVAL OF BUDGET AMENDMENT NO. 2, FOR THE FY 2025 BUDGET (RESOLUTION NO. 2025-3366); PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Surfside (the "Town") desires to rescind its approval of Budget Amendment No. 2 for the Fiscal Year 2025 Budget amending the General Fund to appropriate \$204,319 of current year reserves to fund a Director of Public Safety position in the Executive Department and to fund sandblasting for the Business District, as per Attachment "A" appended to Resolution No. 2025-3366 ("Resolution");

WHEREAS, the Town Commission passed the Resolution on January 14, 2024;

WHEREAS, the Town Commission amended the Fiscal Year 2025 budget by amending the General Fund, as set forth in Attachment "A" appended to the Resolution:

WHEREAS, the Town Commission desires to reconsider its decision to amend the FY 2025 Budget for the purpose of funding a Director of Public Safety position in the Executive Department and for sandblasting work in the Business District; and:

WHEREAS, the Town Commission has concluded that it is in the best interests of the Town to immediately rescind its approval of the Resolution.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA AS FOLLOWS:
