

RESOLUTION NO. 2025- 3380

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, APPROVING THE PURCHASE OF A FIREWORKS SHOW FROM ZAMBELLI FIREWORKS FOR FOURTH OF JULY FIREWORKS SHOW SERVICES; FINDING THAT THE PURCHASE IS EXEMPT FROM COMPETITIVE BIDDING PURSUANT TO SECTION 3-13(7)(C) AND 3-13(7)(D) OF THE TOWN CODE; AUTHORIZING THE TOWN MANAGER TO ENTER INTO A PURCHASE ORDER FOR SUCH PURCHASE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Surfside (Town") intends to host a Fourth of July event at the Town Community Center (the "Event") on July 4, 2025; and

WHEREAS, the Town desires to enhance the Event with a fireworks show ("Services"); and

WHEREAS, the Town seeks to retain a vendor to provide the Services for the Event;

WHEREAS, the Town now desires to purchase the Services from Zambelli Fireworks ("Vendor") for the Event;

WHEREAS, the Vendor has provided a proposed contract attached hereto as Exhibit "A" for the Services at a cost of \$25,000.00 (the "Contract"); and

WHEREAS, in accordance with Section 3-13(7)(c) and (d) of the Town Code of Ordinances (the "Code"), artistic and entertainment services benefitting the citizens of Surfside and the general public at any Town sanctioned activity are exempt from the competitive procurement requirements of Chapter 3 of the Town Code; and

WHEREAS, the Town Commission wishes to authorize the Town Manager to purchase the Services and enter into a Purchase Order with the Vendor, in substantially

the same form as the Contract attached hereto as Exhibit "A"; and

WHEREAS, the Town Commission finds that the purchase of the Services is in the best interest and welfare of the Town.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. Each of the above stated recitals are hereby adopted, confirmed, and incorporated herein.

Section 2. Approval and Authorization. The purchase of the Services in an amount not to exceed \$25,000.00 from Zambelli Fireworks is hereby approved, in accordance with the Agreement attached hereto as Exhibit "A."

Section 3. Exemption from Competitive Bidding. The Town Commission finds that pursuant to Section 3-13(7)(c) and (d) of the Code, the purchase of the Services is exempt from the competitive procurement requirements of Chapter 3 of the Town Code.

Section 4. Implementation. The Town Manager and/or designee are authorized to take any and all necessary or further action to implement the purchase of the Services and effectuate the purposes of this Resolution.

Section 5. Effective Date. This Resolution shall be effective immediately upon adoption.

Transportation: Fireworks and equipment will be delivered by qualified CDL drivers with Haz-Mat endorsed licenses as required by US DOT.

Personnel: Zambelli Certified Pyrotechnicians and Trained Assistants; no subcontractors used.

Safety Procedures: Zambelli Fireworks adheres to all safety regulations. NFPA 1123 code will be strictly enforced.

Terms: 50% deposit at signing of the contract. Balance due at completion of each display, as invoiced by Zambelli
