

**RESOLUTION NO. 2025- 3385**

**A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, SELECTING AND AWARDING AN AGREEMENT FOR LANDSCAPE MAINTENANCE AND RELATED SERVICES TO BRIGHTVIEW LANDSCAPE SERVICES INC. PURSUANT TO RFP NO. 2025-01; PROVIDING FOR AUTHORIZATION; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, on January 6, 2025, the Town of Surfside (Town”) issued Request for Proposals (RFP) No. 2025-01 seeking qualified firms to provide landscaping maintenance work for all Town facilities, including its Park and Recreation Facilities, Parking Lots and Rights of Way (“Work”);

**WHEREAS**, after reviewing the proposal submitted by Brightview Landscaping Services, Inc. (the “Contractor”), the Evaluation Committee determined that the Contractor’s proposal was responsive and recommended award of an Agreement to the Contractor based on the proposal; and

**WHEREAS**, based on the Evaluation Committee and Town Administration’s recommendation, the Town Commission wishes to select the Contractor’s proposal and award the Contractor an agreement for the Work in substantially the form attached hereto as Exhibit “A” (the “Agreement”), subject to final approval as to form and content by the Town Manager and legal sufficiency by the Town Attorney; and and

**WHEREAS**, the Town Commission finds that the award of an Agreement for the Work to the Contractor and this Resolution are in the best interest and welfare of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals Adopted.** Each of the above stated recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. Selection of Contractor and Award of Agreement.** The Town Commission hereby selects the Contractor's proposal and awards the Contractor an Agreement for the Work, in substantially the form attached hereto as Exhibit "A."

**Section 3. Authorization to Execute Agreement.** The Town Manager is authorized to execute the Agreement, in substantially the form attached hereto as Exhibit "A," with the Contractor on behalf of the Town, subject to the approval as to form and legal sufficiency by the Town Manager and Town Attorney.

**Section 4. Implementation.** That the Town Manager and Town Officials are hereby authorized to take any and all actions which are necessary to implement the Services, the Agreement for the Services, and the purposes of this Resolution.

**Section 5. Effective Date.** This Resolution shall become effective immediately upon adoption.
