## **RESOLUTION NO. 2025- 3394**

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, APPROVING THE EXPENDITURE OF FUNDS FOR THE TOWN OF 90<sup>TH</sup> SURFSIDE'S ANNIVERSARY CELEBRATION **RECEPTION: FINDING THAT THE PURCHASE IS EXEMPT** FROM COMPETITIVE BIDDING PURSUANT TO SECTION 3-13(I)F OF THE TOWN CODE AS FOOD AND CATERING AND SECTION 3-13(2) OF THE TOWN CODE AS **PROFESSIONAL SERVICES: AUTHORIZING THE TOWN** MANAGER TO ENTER INTO A PURCHASE ORDER FOR SUCH PURCHASE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, May 18, 2025 marks ninety (90) years since the founding of the Town

of Surfside ("Event"); and

WHEREAS, the Town of Surfside's ("Town") Administration has proposed a

formal Evening Reception to celebrate the Event at the Four Seasons Hotel at The Surf

Club (the "Four Seasons"), a property that is directly tied to the Town's origins

("Reception"); and

WHEREAS, the Reception would be one of five (5) events scheduled throughout

May 2025 to commemorate the Town's milestone anniversary; and

WHEREAS, the Four Seasons has provided a proposal for the Reception

("Reception Contract") (Exhibit "A"); and

WHEREAS, the Event will be outdoors, the Reception will take place beneath a

large event tent on the Four Seasons' premises; and

WHEREAS, the total expenditure for the Event will not exceed \$30,000.00; and

WHEREAS, pursuant to Section 3-13(7)(i) of the Town's Code, food and catering

services are exempt from competitive bidding; and

WHEREAS, pursuant to Section 3-13(2) of the Town's Code, professional services are exempt from competitive bidding; and

WHEREAS, the Event is not funded by the Resort Tax Fund; and

WHEREAS, the proposed contract attached hereto as Exhibit "A" (Reception Contract) (hereinafter, the "Services") shall not exceed \$30,000.00; and

WHEREAS, pursuant to Section 3-6(c) of the Town's Code, the Services in the proposed amount require approval of the Town Commission; and

WHEREAS, the Town Commission wishes to authorize the Town Manager to purchase the Services, in substantially the same form as the contract attached hereto as Exhibits "A"; and

WHEREAS, the Town Commission finds that the purchase of the Services is in the best interest and welfare of the Town and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, AS FOLLOWS:

Section 1. <u>Recitals Adopted.</u> Each of the above stated recitals is hereby adopted, confirmed, and incorporated herein.

### Section 2. Purchase of Services, Approved; Exemption from Competitive

**Bidding.** The purchase of the Services totaling not more than \$30,000.00 from the Four Seasons and its vendors is hereby approved. The Town Commission finds that pursuant to Section 3-13(7)(f) and 3-13(2) of the Town's Code, the purchase of the Services is exempt from competitive bidding.

<u>Section 3.</u> <u>Implementation.</u> The Town Manager and Town Officials are authorized to take any and all necessary or further action to implement the purchase of the Services and the purposes of this Resolution.

**Section 4.** Effective Date. This Resolution shall be effective immediately upon adoption.







# TERMS & CONDITIONS

#### **Dietary Options**

The Four Seasons Hotel at the Surf Club has taken great care to incorporate items into the catering menus that account for diverse dietary and nutritional needs, including gluten-free options.

Additional dietary options or modifications are available and can be resolved to ensure an easily personalized culinary experience for your event.

#### Guarantee

The guaranteed number of attendees at each catered function is required a minimum of three business days, 72 hours, prior to the function. The guaranteed number of attendees shall constitute a guarantee, not subject to reduction, for which charges will be assessed accordingly. You will be charged for the guaranteed guest count or the actual guest attendance, whichever is greater.

If we are not advised of a guaranteed count, the tentative number of guests will become the guaranteed count. If an increase of 10% or more is requested after the final guarantee is received, an additional charge above the food and beverage charges would apply to accommodate the last minute increase. Please note that the kitchen prepares no more than 5% over actual guarantee.

#### Menu and Final Details

All final details (menu selection, room set-up, agenda/schedule of events, etc.) are due in writing to the Catering Manager and Coordinator assigned to your event, (4) weeks prior to the event date.

Banquet Event Orders (BEOs) will be created for each event outlining the specific details and sent for your review/approval. A final signed version of the BEOs is due to the hotel (10) business days prior to the start of your event or program. Your signature on the BEO indicates your acceptance of the estimated number of attendees and event details outlined on the BEO and the Resort's terms and conditions. This important set timeline will allow the hotel to properly prepare and staff for each event. Any adjustment in the noted timeline may result in additional charges or labor fees.

#### **Displays and Signs**

The Hotel will not permit the affixing of any object to the walls, floors, ceilings of rooms or outdoor set ups by nails, staples, tape, spikes or any other substance. Signage, banners, logo, name badges, lanyards and displays are not permitted in Hotel areas.

#### Service Charges and Taxes

A 20% service charge is added to all functions for payment to hourly paid wait staff and service employees involved in the service of the event. An administrative fee of 7% is added to all function and event orders, inclusive of function space rental or public area fees to defer overhead costs. No part of this administrative fee is provided to wait staff or service employees. Taxes will be compiled in strict accordance with local, state or provincial and federal tax regulations.

#### Food Presentation Guidelines

As the health and safety of our quests and team members is our top priority, all food & beverage items will be packaged in individual,

single serve portions. Attended dining experiences are available and require server attendants (fee of \$150 each) to ensure proper food handling. Self-service of non-packaged food & beverage items is not permitted. Buffets will not be stationed for longer then 90 minutes as per Health code guidelines.
