**RESOLUTION OF THE TOWN COMMISSION OF THE
TOWN OF SURFSIDE, FLORIDA CERTIFYING AND
DECLARING THE RESULTS OF THE TOWN OF
SURFSIDE SPECIAL MUNICIPAL ELECTION HELD ON
NOVEMBER 4, 2025, FOR FOUR PROPOSED BALLOT
QUESTIONS; PROVIDING FOR IMPLEMENTATION; AND
PROVIDING FOR AN EFFECTIVE DATE.**

WHEREAS, on August 20, 2025, the Town Commission of the Town of Surfside ("Town") adopted Resolutions 2025-3432, 2025-3433, 2025-3434, and 2025-3435 calling for a special municipal election to submit to the electors four ballot questions; and

WHEREAS, the Town of Surfside ("Town") held a special municipal election on Tuesday, November 4, 2025, for the four proposed ballot questions; and

WHEREAS, the Miami-Dade County Elections Department has canvassed the returns, tabulated the ballots of the mail in votes, and determined the total number of votes at such election for the proposed ballot questions as shown by said returns; and

WHEREAS, the results of the November 4, 2025, Town Special Municipal Election were certified on November 7, 2025, by the Supervisor of Elections, Alina Garcia; and

WHEREAS, such results are attached as Exhibit A" hereto; and

WHEREAS, the Town Commission hereby certifies the election results of November 4, 2025, Town Special Municipal Election.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. The above and foregoing recitals are true and correct and are hereby adopted and incorporated herein.

Section 2. Certification of Special Election. The Town Commission finds, declares and certifies the results of the Special Municipal Election held on November 4, 2025, for the proposed ballot questions pursuant to the Certification of the Official Results for the ballot questions listed herein attached hereto as Exhibit "A".

It is hereby certified and declared that pursuant to the votes cast in the Town of Surfside Special Municipal Election held on April 1, 2025, the following results on the proposed ballot questions are declared and certified:


