

**RESOLUTION NO. 2026- 3475**

**A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, APPROVING THE PURCHASE OF A NEW MACK REFUSE TRUCK FROM NEXTRAN CORPORATION; FINDING THAT THE PURCHASE IS EXEMPT FROM COMPETITIVE BIDDING PURSUANT TO SECTION 3-13(7)F OF THE TOWN CODE AS A PUBLIC WORKS PURCHASE FOR REPLACEMENT OF FLEET; AUTHORIZING THE TOWN MANAGER TO ENTER INTO A PURCHASE ORDER FOR SUCH PURCHASE; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town of Surfside (Town”) is seeking to purchase one (1) Mack (“Vehicle”) to replace a 10-year-old refuse truck in the Public Works fleet which is beginning to break down and requiring consistent repairs as it is approaching end of service life; and

**WHEREAS**, as part of the FY 2026 Budget, the Town Commission approved the purchase of a new refuse truck to replace an existing 10-year-old unit in the fleet; and

**WHEREAS**, this purchase is exempt from competitive bidding pursuant to Section 3-13(7)(f) of the Town’s Code as a public works and utilities purchase of fleet; and

**WHEREAS**, the Town’s Public Works Department secured two quotes attached hereto as Exhibits “A” and “B”; and

**WHEREAS**, the Town’s current refuse fleet consists exclusively of Mack chassis, providing for operational consistency and simplifying maintenance and parts inventory; and

**WHEREAS**, the Public Works Department selected the quote submitted by Nextran Corporation (“Vendor”) in the amount of \$319,998 (the “Contract”); and

**WHEREAS**, the Town Commission wishes to authorize the Town Manager to purchase the Vehicle and enter into a Purchase Order with the Vendor, in substantially the same form as the Contract attached hereto as Exhibit "A"; and

**WHEREAS**, the Town Commission finds that the purchase of the Vehicle is in the best interest and welfare of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals Adopted.** Each of the above stated recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. Purchase of Vehicle Approved; Exemption from Competitive Bidding.** The purchase of the Vehicle in the amount of \$319,998 from the Vendor is hereby approved. The Town Commission finds that pursuant to Section 3-13(7)(f) of the Town's Code, as a public works and utilities purchase of fleet, this purchase is exempt from competitive bidding. The Contract, in substantially the same form attached hereto as Exhibit "A," is hereby approved, and the Town Manager is authorized to execute a Purchase Order for the Vehicle in substantially the same form as the Contract attached hereto as Exhibit "A."

**Section 3. Implementation.** The Town Manager and Town Officials are authorized to take any and all necessary or further action to implement the purchase of the Work and the purposes of this Resolution.

**Section 4. Effective Date.** This Resolution shall be effective immediately upon adoption.
