

**RESOLUTION NO. 2026 - 3509**

**A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, RATIFYING AND APPROVING THE RENAMING OF THE PARK AT BAY DRIVE AND 92<sup>ND</sup> STREET AS “LITTLE BAY PARK”; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.**

**WHEREAS**, the Town Commission explored over the course of 2024-2025 different options to rename the park located at Bay Drive and 92<sup>nd</sup> Street (the “Park”); and

**WHEREAS**, on November 12, 2025, the Town Commission directed Town Administration to seek input from the Town residents for a new name; and

**WHEREAS**, Town Administration conducted a survey in the Town Gazette, Town website, E-blasts and official social media channels for the Town residents to vote on the selection of a new name for the Park; and

**WHEREAS**, from November 13, 2025 through December 2, 2025, the Town’s residents voted on different options for the new name of the Park; and

**WHEREAS**, on February 10, 2026, Town Administration presented the Town Commission with the results of the voting; and

**WHEREAS**, the Town Commission accepted the results of the survey and issued a directive to Town Administration to re-name the Park to “Little Bay Park”; and

**WHEREAS**, the Town Commission now seeks to ratify and approve that directive in the form of a Resolution; and

**WHEREAS**, the Town Commission finds that such actions are in the best interests and welfare of the Town.

**NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals Adopted.** Each of the above stated recitals are hereby adopted, confirmed, and incorporated herein.

**Section 2. Park Renamed.** The Town hereby ratifies and approves the renaming of the park at Bay Drive and 92<sup>nd</sup> Street to "Little Bay Park."

**Section 3. Implementation.** The Acting Town Manager, Town Attorney and Town Officials are authorized to take any and all necessary or further action to implement the purposes of this Resolution.

**Section 4. Effective Date.** This Resolution shall be effective immediately upon adoption.


