

RESOLUTION NO. 2026-3520

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA CERTIFYING AND DECLARING THE RESULTS OF THE TOWN OF SURFSIDE MAYORAL RUN-OFF ELECTION HELD ON APRIL 7, 2026; PROVIDING FOR IMPLEMENTATION; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Town of Surfside ("Town") held a general municipal election on Tuesday, March 17, 2026, for the election of Mayor and four Commissioners of the Town of Surfside, Florida ("Election"); and

WHEREAS, the Mayoral race was set for a run-off election that was held on Tuesday, April 7, 2026; and

WHEREAS, on April 6, 2026, the Eleventh Judicial Circuit Court granted plaintiff's petition for temporary injunction in part extending the Vote-by-Mail deadline in the Mayoral race until Tuesday, April 28, 2026; and

WHEREAS, the Miami-Dade County Elections Department has canvassed the returns and tabulated the ballots of the mail in votes, and has determined the total number of votes at such election for the Mayor's race as shown by said returns; and

WHEREAS, the results of the April 7, 2026, Run-Off Election were certified on Friday, May 1, 2026, by the Office of the Supervisor of Elections, Alina Garcia, attached as Exhibit A" hereto; and

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, AS FOLLOWS:

Section 1. Recitals Adopted. The above and foregoing recitals are true and correct and are hereby adopted and incorporated herein.

Section 2. Certification of Run-Off Election. The Town Commission finds, declares and certifies the results of the Run-Off Election held on April 7, 2026, for the Mayor's race pursuant to the Certification of the Official Results attached hereto as Exhibit "A".

It is hereby certified and declared that pursuant to the votes cast in the Run-Off Election held on April 7, 2026, Shlomo Danzinger was duly elected Mayor of the Town of Surfside for the term which shall commence at 8:00 p.m. on the day following his election in accordance with Town Charter Sec. 19, and end on the first Tuesday in November 2028.

Section 3. Implementation. The Town Clerk is hereby authorized and directed to take all action necessary and perform all incidental duties in connection herewith as required by law.




