**A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF SURFSIDE, FLORIDA, RATIFYING THE EXPENDITURE TO DIAMONETTE PARTY RENTAL FOR THE FIFTH ANNUAL CTS REMEMBRANCE EVENT HELD ON JUNE 24, 2026 IN THE AMOUNT OF \$19,316.17; PROVIDING FOR AUTHORIZATION, IMPLEMENTATION, AND AN EFFECTIVE DATE.**

**WHEREAS**, Town Commission of the Town of Surfside ("Town") wishes to ratify the expenditure to Diamonette Party Rental ("Provider") for the fifth annual CTS Remembrance Event held on June 24, 2026, in the amount of \$19,316.17; and

**WHEREAS**, Provider provided the services as detailed in the Invoice attached hereto as Exhibit "A"; and

**WHEREAS**, the Town finds that ratification of the expenditure to Provider in connection with the production of the fifth annual CTS Remembrance Event is in the best interests of the Town and its residents, and the public health and welfare.

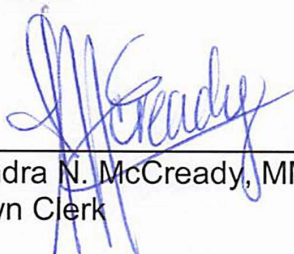

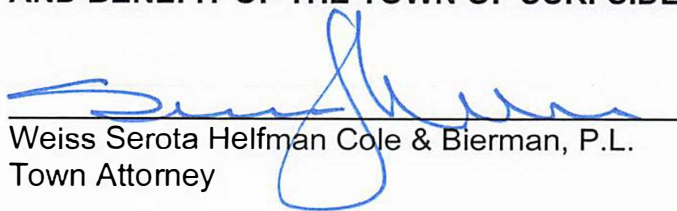
