31 **WHEREAS**, the Town Commission wishes to reestablish and reinstate the Sister City
32 relationships and honor and respect the history, traditions, and communities represented by
33 Quintana Roo, Hialeah, and Shomron, and to restore the bonds of friendship and
34 cooperation that were previously established between the Town and each of these
35 communities; and

36 **WHEREAS**, the Town Commission wishes to express its appreciation to the
37 residents, leaders, and organizations of Surfside, Quintana Roo, Hialeah, and Shomron who
38 fostered and sustained these relationships in the past, and looks forward to renewing active
39 partnership and engagement with each community.

40 **NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COMMISSION OF THE**
41 **TOWN OF SURFSIDE, FLORIDA AS FOLLOWS:**

42 **Section 1. Recitals.** The above recitals are true and correct and incorporated
43 herein by this reference.

44 **Section 2. Reestablishment and Reinstatement of Sister Cities.** The Town
45 Commission hereby reestablishes the Town's sister city relationships with Chetumal,
46 Quintana Roo, Mexico; the City of Hialeah; and the Region of Shomron, Israel.

47 **Section 3. Implementation.** The Town Mayor and Town Officials are hereby
48 authorized to take any and all actions, which are necessary to implement the purposes of
49 this Resolution.

50 **Section 4. Notification.** The Town Manager, or designee, is hereby directed to
51 notify Sister Cities International, of which the Town of Surfside is an active member, of the
52 reestablishment of these Sister City relationships for appropriate publication and inclusion
53 in its official records.

54 **Section 5. Effective Date.** This Resolution shall take effect immediately upon
55 adoption.

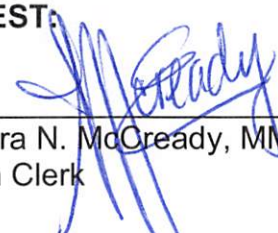

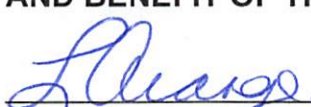
