18	Commission of the Town of Surfside ("Town") shall fix its rules of procedure; and
19	WHEREAS, the Town Commission now seeks to amend Article VI, Rules of
20	Procedure of Town Meetings, Section 2-205, Conduct of Meetings; Agenda, Rule 6.06 as
21	set forth in Town Code; and
22	WHEREAS, the adoption of the provisions set forth below are necessary to
23	accomplish the above objectives; and
24	WHEREAS, the Town Commission held its first public hearing on June 10, 2025,
25	and approved the proposed amendment to the Code of Ordinances having complied with
26	the notice requirements in Florida Statutes; and
27	WHEREAS, on July 8, 2025, the Town Commission deferred the proposed
28	amendment to the Code of Ordinances to its next special meeting on August 12, 2025;
29	WHEREAS, the Town Commission held its second public hearing on Aug. 12
30	2025, and approved the proposed amendment to the Code of Ordinances having
31	complied with the notice requirements in Florida Statutes; and
32	WHEREAS, the Town Commission hereby finds that this Ordinance is in the best
33	interest and welfare of the residents and visitors of the Town.
