- 96th Street Park
- Kayak Launch

- Beach Lifeguard Tower
- Beach Chair Service

Facility Updates

- **Tennis Center/Pickleball:** Open from 7 am 10 pm daily. Operates by reservation only. Programming hours are in place and have been adjusted to optimize availability.
- Aquatic Facility: The pool continues to operate with lap swimming registration required during all operating hours. Pool hours are adjusted monthly to maximize daylight. For December, the pool is open from 7:00 a.m. to 6:00 p.m.
- Beach Lifeguard Tower: Operational from 10:00 a.m. to 6:00 p.m. in December.
- 96th Street Park: Now open daily from 8:00 a.m. to 9:00 p.m.
- Kayak Launch & Playground: Open daily from 8:00 a.m. to sunset.

Beach Chair Service: The daily Beach Chair Service is operated by Beach Time Max in alignment with the Beach Lifeguard Tower hours (10:00 a.m. to 6:00 p.m. in December). This service is available exclusively to Surfside residents. Residents must check in at the Community Center front desk. Each household is eligible for 2 chairs and 1 umbrella per day.

96th Street Park Enhancements

• **Basketball Courts:** The 96th Street Park basketball courts have been fully resurfaced and repainted, improving appearance, playability, and line visibility. The work restores proper traction, sharpens boundary markings, and extends the service life of the courts.

Community Center Enhancements

• **Lighting:** Electrical outlets were added along the Surfside Community Center frontage to support holiday lighting, and three new spotlights were installed to illuminate the facility's flagpoles.

Town School (Ruth K. Broad Bay Harbor K-8) Shuttle: The Town is currently working with the Shuttle Bus provider to implement a GPS-based rider tracking system that allows parents to view the bus location in real time and receive notifications.

As the primary bridge between Town Administration and its citizens, the department ensures transparency, accessibility, and unity within our community, promoting active civic engagement and celebrating Surfside's unique heritage. Through innovative partnerships and implementing forward-thinking strategies, the department strives to position Surfside as a model of effective governance and vibrant community participation.

In November 2025, the Communications Department continued to serve as the creative and strategic engine of the Town of Surfside, supporting every department with clear, consistent, and engaging messaging. From major video productions and civic outreach to daily content management and cross-departmental collaboration, the Department ensured all initiatives were elevated, accessible, and aligned with the Town's core values of transparency, service, and community pride.

Town Manager's Office:

- Produced and distributed the December 2025 Gazette ahead of schedule, providing residents with timely updates on new Town leadership, holiday programming, meeting schedules, and public safety information.
- Highlighted key features across digital platforms, including the introduction of the Acting Town
 Manager, the new Finance Director, and the new Parks & Recreation Director. Promoted Town
 staff participation in the Emotional Intelligence Workshop, emphasizing communication and
 teamwork.
- Launched a communications campaign supporting the December holiday events, including the Christmas Tree Lighting, Winter Wonderland, and Senior Brunch.

- Issued a comprehensive announcement on the Beach Renourishment Project taking place Nov.
 17 Dec. 23, 2025, detailing scope, impacts, and schedule to ensure transparency and public awareness.
- Distributed the community survey and launched voting for the new name of the park at Bay Drive & 92nd Street, encouraging residents to select from three finalists: Little Bay Park, Flamingo Native Garden, and Tequesta Tribe Park.

Police Department:

- Informed residents that Sgt. Lorente was available in the Town Hall lobby on Election
 Day, Nov. 4, to assist with the new Residential Virtual Parking Permit Program.
- Production of two public safety videos now in development: a holiday traffic reminders message with Chief Press and a holiday safety tips video with Major Matelis.
- Promoted the Mobile DMV (FLOW) visit to Town Hall and supported the Town's Hurricane
 Melissa Relief Drive, encouraging residents to donate essential supplies.
- Documented and promoted the Police Department's Thanksgiving community outreach, including turkey and holiday meal deliveries to families with support from Chief Press,
 Sgt. Cruz, the Chief Press Foundation, and Closet of Living Hope.
- Covered Chief Press's leadership at the 10th Annual Veterans Thanksgiving Lunch hosted at LoanDepot Park for Miami-Dade County veterans, recognizing multi-agency partners, Royal Caribbean, Starbucks, and event sponsors.

Parks & Recreation Department:

- Produced a Parks and Recreation video featuring Director Rudy Perez, highlighting and showcasing the features of the Parks & Recreation mobile app for easy class and program access.
- Promoted and documented the Veterans Day Ceremony at Veterans Park, honoring those who served with participation from Town officials and the Surfside Police Department Honor Guard.
- Covered Movie Under the Stars, where more than 100 residents enjoyed an outdoor screening of Disney's "Lilo & Stitch," and promoted the next film scheduled for Dec. 6.

 Announcement of Community Center Beach Club limited service due to the ongoing beach renourishment project.

Public Works:

- Distributed timely alerts regarding beach renourishment activity, truck traffic, and project timelines through email and social media.
- Maintained active communication channels to support public understanding of project impacts.
- Communicated Thanksgiving holiday hours to changes to recycling collection shifts, traffic alerts, and emergency notifications to keep residents informed and prepared.

Town Clerk's Office:

- Promoted the upcoming Clean Campaign Class scheduled for Dec. 4, providing residents with an opportunity to learn about campaign law, reporting requirements, and election compliance standards.
- Published Nov. 4 Special Election Results, including outcomes of the referendum on undergrounding utilities, the non-binding gated community referendum, and the two charter amendments requiring enhanced fiscal oversight.

<u>Digital Strategy, Social Media & Brand Stewardship:</u>

- Oversaw all social media content and platform growth, resulting in increased organic engagement and community interaction. The Town's <u>Instagram following</u> grew to 2,800, marking a 6% increase compared to last month.
- Delivered content in clear, accessible language that aligned with the Town's visual identity and values.
- Managed content creation across multiple platforms, ensuring consistency in tone, message, and visual branding.
- Distributed <u>23 e-blast campaigns</u>, posted 47 Nextdoor alerts, and published 36 Instagram/Facebook posts, maintaining strong communication and engagement with residents.



TOURISM DEPARTMENT

Surfside is one of only three municipalities in Miami-Dade County currently eligible by Florida State Law to impose a Resort Tax of four percent (4%) on accommodations and two percent (2%) on food and beverage sales as a source of revenue. Miami Beach and Bal Harbour are the other two municipalities with the same capability. This unique revenue-generating opportunity is also defined in the Town's Charter in Sec. 69-A.

Resort Tax. The Tourist Resort Tax Fund is a special revenue fund within the budget of the Town of Surfside. This means that the funds, like all special revenue funds, are collected from specific sources and dedicated to specific allowable uses. The Resort Tax Board Members, appointed by the Town's Commission, oversee the legal and appropriate use of these funds through the Tourism Director and the operations of the Tourist Bureau. The Tourist Bureau is responsible for promoting the Town's dining, shopping, lodging, recreation and beach to visitors nationally, internationally, and within the State of Florida. Attracting visitors from within the State of Florida, the nation, and internationally, including from Latin America, Canada, United Kingdom, and Israel.

Second Annual Christmas Tree Lighting Ceremony – The Resort Tax Board sponsored the Second Annual Christmas Tree Lighting Ceremony at Town Hall on Sunday, Dec. 7. The event, which was supported by more than 20 Town volunteers including teens and members of the Youth Council, Board and Committee members and residents of all ages, proved to be a success exceeding last year's impressive turnout. The Tree Lighting also featured a visit from Santa Claus, a live orchestra, holiday music, hot chocolate, and a variety of sweet & savory holiday treats. The Resort Tax Board continues to expand its scope for holiday lighting, adding illumination to the palm trees at Veteran's Park and the Community Center for the first time ever this season. New custom turtle monument signs have also been installed at Town entrances in addition to redesigned holiday street banners.





96th Street Park

Scope:

The project is a full park re-development with a 2-story multi-use structure, natural grass field, and playground area. A kayak launch component has also been incorporated.

Phase: Construction Closeout

Status: The Town have retained a Construction Law firm to handle the Lunacon settlement.

Townwide Utilities Undergrounding

Scope:

The project consists of the undergrounding of all current above ground utilities throughout Town. These utilities include electrical mains, feeders, communications and residential drop connections.

Phase: Design

Status Update:

During the November 2025 election, voters voted "No" to the question "Shall the Town continue with the undergrounding of overhead utility lines for electric and communication services (the "Project") at an anticipated cost of Eighty Million (\$80,000,000) Dollars?" As a result, the project has been halted in its entirety, including all design work for Areas 1 and 2, as well as the planned construction of Area 3.

Surfside Memorial

Scope: The Town is seeking to create the Surfside Memorial to honor and remember the lives lost in the tragic event that occurred on June 24, 2021, when the CTS Building collapsed. The Surfside Memorial will serve as a permanent remembrance of the immense loss suffered by the Surfside community and will offer a place for families, friends, and visitors to reflect, understand the truth of that day, and find solace through the peace and serenity conveyed through this site.

Phase: Design

Status: The town is coordinating with MDSO to collect the debris that will be used in the constriction of the memorial. The town is actively looking for storage lots that can be used to store the debris once received from MDSO. Keith team has sent over 100% design for review after which the design will be submitted to the relevant permitting agencies for review and approval.

Project Schedule:

- Detailed Design Milestones:
 - 30% Design July 2025
 - 60% Design August 2025
 - 90% Design September 2025
 - Final Design November 2025
- Site Plan, Permitting & Opinion of Probable Cost:

Abbott Avenue Drainage

Scope:

The construction will entail the addition of two new pump stations with respective force mains to alleviate flooding on Abbott Avenue from 90th Street to 94th Street.

Phase: Construction

Status: The Town has secured construction litigation lawyer to handle the settlement with Ric Man International regarding this project.

FG Construction has begun work on 91st Street between Harding and Abbott Avenue, with all DERM and FDEP permits approved.

In parallel, the Town continues discussions with Ric-Man International regarding their claim for outstanding payments. Ric-Man currently retains critical materials required for the construction of Pump Stations No. 1 and No. 2, and negotiations are ongoing to resolve the **matter.**

Collins Avenue Water Main

Scope:

Pursuant to Town Resolution 2022-2907 passed and adopted unanimously on August 9, 2022, Nova Consulting was selected to design this project to replace the current, undersized water main on Collins Avenue. The existing water main is past its useful life and requires up-sizing and replacement. The Town sought and obtained a grant for design services for the project. The water main currently services all the facilities along the Collins Avenue corridor.

Phase: Design

Status: Nova Consultants has submitted the **100% design package** to both the **Town** and **FDEP** for review and approval. Nova is also continuing its **permitting efforts with other governing agencies** to ensure the project progresses as planned.

The Capital Improvement Program (CIP) team is actively exploring alternative grant funding opportunities to support the project's implementation.

Construction is currently **anticipated to begin in the first quarter of 2026**.

Dune Restoration

Scope:

The Commission tasked Town administration to promote both dune beautification and resiliency improvements. Kimley-Horn was tasked to design the required resiliency improvements and

beautification of the Town's dunes.

Phase: Construction

Status: The Town finalized all design-related matters in coordination with Kimley-Horn and issued the requisite addendums to support the bidding process. The Invitation to Bid (ITB) was opened on November 26, 2025, at 11:00 a.m., during which the Town received a single bid. The Town is currently evaluating options and determining an appropriate path forward. Construction is

projected to commence in the first quarter of 2026.

Townwide Vulnerability Assessment

Scope:

The Town of Surfside was awarded a grant for \$300,000.00 from the Florida Department of Environmental Protection to conduct a Vulnerability Assessment and an Adaptation Plan as well as the development of the Town Hall's Emergency Operation Center EOC Adaptation Plan.

Phase: Study

Status: Kimley-Horn has submitted the Emergency Operations Center (EOC) Adaptation Plan Feasibility Report and the Final Vulnerability Assessment Report to the Florida Department of Environmental Protection (FDEP) for review and approval. The town currently waiting on FDEP's approval.

Following FDEP approval, the Town intends to identify potential projects outlined in the reports

and pursue grant funding to support their implementation.

These efforts are part of the Town's ongoing commitment to resilience planning and enhancing infrastructure to better withstand future climate and hazard impacts.
