• The Town has made significant backend configuration changes to the Energov CSS online building and permitting system with guidance from our Energov consultant. These improvements are part of a 2023 update that hasn't yet gone live for our staff and the public, pending troubleshooting in our online training environment by the consultant. Furthermore, the process to enable our building inspectors to directly update their inspection notes electronically in the field using tablets has been initiated, and Town staff is in the process of scheduling training sessions with the consultant to ensure all inspectors are proficient with this new system.
