#### Abbott Avenue Drainage

- Ric Man contract was executed and NTP was issued for September 1<sup>st</sup>
- FDEP has awarded the Town with additional finding of \$3,000,000

#### 96th Street Park

Construction is 95% complete with a targeted substantial completion in mid-September. Targeted substantial completion will allow for all areas on the park to be accessible except for the upper floor until the rail for the west staircase is installed. The rail will be installed in October 2024 due to long manufacture lead time. The building is 90% completed awaiting the west stair rails and final inspections. The exterior is pending basketball court painting, concrete to sidewalk, final landscaping and coquina installation. Contractor is working on pending items. Final completion to be completed by mid-October 2024.
