### Code of Care and Conduct COVID-19 Business Reopening Pledge Agreement

*Reopening Businesses Must Comply with Miami- Dade County's New Normal Guide*

Miami-Dade County Mayor Carlos A. Gimenez has signed Emergency Order 23-20, allowing for the reopening of business establishments previously deemed as non- essential during the County's COVID-19 response.

In Surfside, restaurants, office spaces, retail and personal grooming businesses that are in compliance with the County order may reopen Monday, May 18. In order for your business to reopen, you must sign this pledge agreement and adhere to the following requirements.

CDC Guidelines:

- Employees and customers must wear facial coverings
- Maintain a safe social distance (at least 6 feet between you and others)
- Avoid gatherings of more than 10 people
- Wash hands and use hand sanitizer often

**In addition to the CDC guidelines, businesses must adhere to measures required by Miami-Dade County under Emergency Order 23-20, but not limited to: requirements for personal protective equipment, changes in capacity and industry-specific instructions.**

“The New Normal” guidebook (<https://www.miamidade.gov/information/library/new-normal.pdf>) from Miami-Dade County outlines these requirements. **Before reopening you MUST read and adhere to Pages 20-22 of the guidebook, which outlines general guidance for all businesses. You MUST also read and adhere to the industry-specific guidance found on the pages below:**

- Retail Establishments - Pages 23-25 and Page 28
- Personal Grooming - Pages 23-28  
(Note: Retail guidelines also apply to personal grooming establishments)
- Arts & Culture - Pages 29-31
- Office Spaces and Shopping Centers - Pages 35-37

- Restaurants - Pages 41-54

Additionally, barbershops, cosmetology salons, and cosmetology specialty salons shall adopt appropriate social distancing and precautionary measures outlined in the Department of Business and Professional Regulation at: [www.myfloridalicense.com/emergency](http://www.myfloridalicense.com/emergency).

Please ensure that you read and comply with both the general requirements and the industry-specific one. You will be responsible for ensuring that your business follows all outlined instructions when reopening. Pursuant to Emergency Order 23-20, in order to reopen, businesses must allow the entry of County personnel for the purpose of inspection for compliance.

The undersigned business and owner hereby agree to the terms and conditions of this Code of Care and Conduct Pledge Agreement. The undersigned Owner or Operator represents and warrants to the Town of Surfside that he/she is the lawful owner or operator of the property and has full authority to execute this Code of Care and Conduct Pledge Agreement.
